Overview

The Consumer Horticulture Community of Practice (CHCoP) is comprised of extension faculty in consumer horticulture, faculty with programs related to consumer horticulture such as integrated pest management, and extension faculty coordinating the volunteer Extension Master Gardener program. Major accomplishments

- Imported Fire Ants CoP did a soft launch April 9 and public launch April 24-26, 2007, consisting of basic information, FAQs, a fire ant video, two on line publications/learning lessons, and extensive links to other information about fire ants.
- FAQs: 101 FAQs have been reviewed by the CoP, copy edited, and published. The current FAQ's have been translated into Spanish and will soon be published.
- Chats: 1 in 2006 targeted audience of Extension agents and other interested parties.

Description of works in progress

- Learning Lessons: Delays in programming pushed back the expected publication date of our flagship decision modules. The modules, on fire ant management for homeowners and cattlemen, are in review, with an expected publication date of February 2008.
- Some of the Spanish materials will be ready at the time of the integrated launch February 2008, and the rest will be ready by June 2008
- Year 2 deliverables (Youth Module, additional on line publications, are on track for completion by the integrated launch in February 2008)
