ADAMS COUNTY 4-H BUCKET CALF PROJECT

PURPOSES:

1. To teach proper health care, environmental needs and nutritional requirements of young cattle.
2. To teach basic beef/dairy management skills without a large investment.
3. To teach basic record keeping and communication skills.
4. To provide a better understanding of the cattle industry.
5. To teach compliance to the Country of Origin Labeling mandates.

FIRST YEAR BUCKET CALF PROJECT GUIDELINES:

1. Project open to 4-H members in Adams County who have an "active member" status and are between the ages of 8-12 years old.
2. 4-H member must be enrolled in the Bucket Calf Project.
3. Any newborn or orphan calf...steer, bull, or heifer...beef, dairy, or cross...purebred or crossbred and must have calved between January 1 and April 1 of the current year.
4. Calves may be purchased but must be in the possession of the 4-H member and tagged by April 15th.
5. Calf must be bucket or bottle fed. No nursing permitted.
6. Member may **identify up to three animals** but will be limited to **one calf for exhibit** at fair.
7. First year calves are only eligible to be shown in the Bucket Calf classes only.
8. Calves must be identified with 4-H ear tag on the Bucket Calf Identification Sheet and turned into the Extension Office by the ID deadline.
9. Exhibitor must have completed Quality Assurance class by June 15th of the current year.
10. **NOTE:** Second Year Bucket Calf must have been shown the previous year and qualified by virtue of the above guidelines. Refer to fair book for specific guidelines for second year calf project.

PROJECT EVALUATION:

1. The project will be evaluated on a four-part, 400 point system:

Written Records	200
Oral Interview	100
General Health and Well-being	50
Showmanship and Fitting	50
2. Written records should be completed and turned in at the Beef weigh-in on Fair Entry day.
3. General health, fitting and showmanship will be evaluated during the fair in a show ring evaluation.
4. Ribbon placing will be based on overall points given for the written records, interview, general health and well-being, fitting and showmanship. Champion and reserve champion awards in the Bucket Calf class will be based on overall points (400 total).

COUNTY FAIR REQUIREMENTS

1. Calves will be shown at halter and fitted according to beef or dairy guidelines. The class, if needed, will be divided according to age of exhibitor as of January 1 of the county fair year. At the discretion of the show superintendent, further class divisions may be made based on number of entries.
2. Entries will be weighed at fair during time indicated in the fair book.
3. Show ring evaluation will occur at the fair.
4. See health requirements listed in the current fair book.
5. Judging of the Bucket Calf class will be based on:
 - What member has learned about care and management of raising the calf/calves.
 - The fitting and showing of the calf with emphasis on what the member has learned.
 - General health, condition and management of the calf and member's knowledge of project.
 - Accurate and complete records of the Bucket Calf project.
6. Members are encouraged to keep animals and enter them in appropriate beef or dairy classes next year.

PROJECT DATES:

January 1 – April 1: Animal must be born during this time and the Member enrolled in Bucket Calf project must purchase and have calf/calves in their possession. Second year calves must follow guidelines for previous year.

ID Sheet: Bucket Calf Project Identification Sheet must be in the Extension Office by deadline listed in the current newsletter or fair book.

Entry Day at Fair:

- All bucket calves must be entered and stalled on fairgrounds by specified deadline.
- Record books should be completed except for ending weight before Fair Entry day.
- All 1st and 2nd year bucket calves will weigh-in during the scheduled Beef Weigh-in time on Fair entry day, and weight entries are to be recorded in the record books. The completed record book is to be turned to the 4-H personnel at this time also.
- Interviews for Bucket calf project – Times will be set and you will be informed of your scheduled interview time. Conflicts with other Adams County Fair events must be reported to the Beef Superintendent as soon as possible.

Show Time: 1st year and 2nd year Bucket Calf classes will be held during the Adams County 4-H Beef Show.

After Show: Record books will be returned to the exhibitor. Complete profit and performance summary.

September 15: All Bucket Calf project records should be completed and turned into your leader or the Extension Office.
