#### IMPORTANT ENTRY DEADLINES:

- **❖ HORSE IDs DUE June 1 for State, June 3, 2024 for County** (please ID <u>ALL</u> horses you may have to use during the season.)
- Advancement Levels must be completed for State 4-H Horse Show Entries by June 1, 2024
- **❖** STATE HORSE SHOW ENTRIES DUE via ONLINE ENTRY 5:00 PM JUNE 1, 2024.
- **❖** State 4-H Hippology Contest and the State 4-H Horse Judging Contest Entries due June 1, 2024. Entries can be downloaded at https://4h.unl.edu/horse-expo-contests#hippology.
- **❖** Advancement Levels for county competition at Cherry County 4-H Horse Show must be completed and turned in to the Extension Office by July 15, 2024.

#### **Horse IDs**

Horse IDs will be due by June 1, 2024. ID forms can be downloaded at https://4h.unl.edu/documents/Horse/F29777%20Horse%20ID%20new.pdf

Please be sure to ID all horses that may be used during the season. Horses that are not ID by June 1<sup>st</sup> will not be able to be used. IDs need to be mailed, emailed to emillar2@unl.edu, or dropped off to the Extension office by the June 1<sup>st</sup> deadline. **Text message IDs will not be accepted**.

#### **Horse Advancement Levels**

- a. Levels Testing requirements are listed in detail in the following information. All testing and proof of completion must be submitted to the Extension Office no later than July 15, 2024 for County Fair competition.

  Note above, the ONLINE ENTRY deadline for State is 5:00pm June 1, 2024! NO LATE ENTRIES will be accepted. It is the responsibility of the Horse Project members to verify the appropriate level has been passed for their age or event as shown below. Call/Text Eve if you have questions. - b. <u>Plan ahead and order the Advancement Levels book so it is available for signatures of leaders doing the testing.</u> <u>4H 426 must be obtained from marketplace.unl.edu.</u> <u>The 4H Horse Project Member Manual, 4H 458, must also be purchased as it is needed for studying in preparation for the written tests. (the direct links to these books are listed above)</u>

<u>Purpose of Levels Testing</u>: The levels of advancement in the 4-H Horse Project are designed to serve as guides for instruction and evaluation of each member's progress. The correct handling of horses is emphasized from

the beginning level to the most advanced level. This emphasis will develop the member's self-discipline, patience, self-reliance, responsibility and pride of accomplishment within the horse project.

### **LEVEL 1-3 REQUIREMENTS**

<u>Written exam:</u> Level I, II, III Written Exams: Administered at Extension Office 8:30 am-12:00 pm or 1:00 pm – 4:30 pm. Please allow yourself plenty of time to take the test between these hours and **SET UP YOUR TEST APPOINTMENT TIME IN ADVANCE** by calling 402-376-1850.

**Skills test:** can be completed at scheduled Ride Nights or by appointment.

<u>Demonstration:</u> <u>Skills test:</u> can be given at 4-H Meetings, at Ride Nights or to any Horse Leader.

## **District and State 4-H Horse Show:**

THERE WILL BE NO DISTRICT SHOWS THIS YEAR

#### STATE 4-H Horse Show will be held in Grand Island July 13-17, 2024.

- a. State Horse Show is applicable to members 8 and older (8 & 9 year-olds limited to Levels 1 & 2). Information about this show is available at <a href="https://4h.unl.edu/horse">https://4h.unl.edu/horse</a>
- b. To enter the Fonner Park State 4-H Horse Show, all youth must complete the <a href="Horsemanship Advancement Level requirements">Horse identification process</a>, and <a href="horsemanship process">entry process</a> by **5:00 p.m. on**June **1**. See details below. No late entries will be accepted. No refunds will be given. If youth enter classes for which they are no eligible or if youth decide not to participate, their entry fees will be forfeited. Before beginning, please review all the <a href="horse-show rules">State 4-H Horse Show and Judging Guide</a>.

#### **County Fair:**

- a. Horse ID sheets for County Fair participation are due to the Extension Office by <u>June 3, 2024.</u> They are available at the office or at <a href="http://4h.unl.edu/documents/Horse/F29777%20Horse%20ID%20new.pdf">http://4h.unl.edu/documents/Horse/F29777%20Horse%20ID%20new.pdf</a>
- b. The **County Fair 4-H Horse Show**, including the Working Ranch Horse and Break Away Roping competitions, will be **Tuesday August 6, 2024**. Entry forms will be posted on the web site with all other county fair entry forms at a later date. 4-H County Horse Show entries will be **due to the Extension office on July 15**. The stock fee for Working Ranch Horse and Roping will be due with those entry forms.
- c. Dress code requirements can be found in the Nebraska 4-H Horse Show and Judging Guide (4-H 373). (Arm bands are no longer required on the County level.) This is available for purchase from https://marketplace.unl.edu/default/4h373.html.
- d. It was decided by the Livestock Committee to drop Horse from the Round Robin Showmanship Competition which is usually held on Saturday during the county fair.

#### STATE HORSE SHOW

- \*\* Must be completed no later than June 1, 2024.
- \*\* Extension personnel must certify that proper levels have been passed <u>before</u> entries can be submitted.

<u>Advancement Level Records</u>: Each 4-Her <u>must provide a copy</u> of the Record Sheet from the 4-H Horse Project Advancement Levels book. The Record sheets must be completed entirely and signed by the testing leaders to be noted as a successful pass. <u>Plan Ahead</u>: Completing the levels testing requirements is a process. Waiting to complete the requirements at the last minute is not recommended. **Only one horse may be used for the entire skills (riding) test for each level.** Horses used for Advancement Level III should be at least 3 years old, and at least 4 years old for Advancement Level IV.

**Demonstrations:** A different demonstration must be done for each advancement level.

<u>Written Exams</u>: Written tests are to be taken for Level I, II, and III. These exams are administered at the Extension Office. Questions for each exam are taken from the following:

Level I, II, III, IV	Nebraska 4-H Horse Project Manual Nebraska 4-H Horse Show and Judging Guide
Level III, IV	Horse Science (available to borrow from Extension Office or purchase at <a href="https://shop4-h.org/collections/animal-agricultural-science-curriculum">https://shop4-h.org/collections/animal-agricultural-science-curriculum</a> )

<sup>\*\*</sup>No written exam will be given for Level IV; however, oral questions will be asked during the skills test. Questions on the skills test were taken from the same sources as those of Level III.

Levels Passing Requirements: A passing grade of 80 percent must be received on any written test and proficiency demonstrated on all areas on the advancement levels test to gain eligibility to advance to the next level of certification. Levels testing must be completed in sequential order starting at Level I. If a 4-H member fails to pass any section of the levels test that entire section must be repeated, until is it passed. Each part of any level may be repeated as many times as necessary for successful completion. However, only two attempts per day are allowed for the written exam. Level advancement will not be granted to a 4-Her until all parts

(written exam, demonstration, etc.) of each advancement level (Level I, II, III, or IV) are completed satisfactorily. If 4-Hers need special testing considerations, please discuss this with Extension Staff.

<u>Levels Testing Examiners</u>: Each section of an advancement level record sheet must be signed and dated by a certified examiner. UNL requires leaders that do skills testing to complete a certification course in order to give Level I and Level II skills test. Below is a listing of who can observe and sign off on levels testing requirements.

**Skills (Riding) Tests:** Only certified individuals can conduct the riding skills test.

## **CHERRY COUNTY HORSE 4-H PRACTICE REQUIREMENTS AND EXPECTATIONS**

These are guidelines approved and set forth by the Cherry County Horse 4-H Committee. These guidelines were implemented in the 2018 calendar year. These guidelines are open to amendment by the committee members.

- 1. All members must be enrolled in 4-H.
- 2. Participants shall follow all rules and guidelines outlined by the Nebraska Horse 4-H Manual and 2023 Nebraska 4-H Horse Show & Judging Guide. (Manuals and rulebooks can be ordered from https://marketplace.unl.edu/extension/nebraska-4-h/4-h-curriculum). It is the member's, as well as the parent's, responsibility to read that information, so they know what is expected. By doing so, they can be prepared at practices and clinics. If they have questions, they will be able to ask a leader.
- 3. All 4-Hers who participate must be accompanied by a parent or legal guardian (this is for liability purposes). Parents are encouraged to follow along during practices, so that they can help their children practice at home. If a parent does not accompany their child, the child will not be allowed to participate.
- **4.** It is expected that each child will attempt to pass the Horsemanship Advancement Levels and prepare to show at the County Fair Horse Show.
