Poultry

Rules

- 1. Health Requirements health certificate is not required for poultry. No additional testing requirements for Nebraska-origin poultry for fair entry. Flock numbers may be required for poultry obtained out of state. Note: The Nebraska Department of Agriculture may do disease screening testing on poultry being exhibited.
- 2. Number of Entries per Exhibitor A 4-H member is limited to exhibiting two (2) entries per class. Pre-entry is required.
- 3. Display Cages Exhibitors must provide their own display cages, watering devices, & feed bowls.
- 4. Poultry must be owned by the exhibitor.
- 5. Broiler is a young chicken of either sex, 6 8 weeks of age.
- 6. There is a Poultry Division at State Fair. Contact the Extension Office for more information or visit the website at Nebraska 4-H: 2023 Fairbook (unl.edu)
- 7. Exhibitors must wear the official Cherry County 4-H t-shirt or a white shirt with a 4-H armband during the show, along with jeans, and close-toe shoes. No hats, visors, or headbands.
- 8. Breeds To be eligible for breed exhibition, cockerel, pullet, cock, or hen poultry entries must be fair representatives of the breeds and must be listed in the American Poultry Association Standard of Perfection or the American Bantam Association Standard of Perfection.
- 9. Production Trio A pen of egg production birds can be hybrids, crossbred, or purebred and shall consist of 3 sexually mature females. Egg-production females will be judged for production qualities only and need not necessarily conform to breed standards. Hens must be in egg production.
- 10. Rules for Bantam & Other Poultry The rules for standard-size chickens apply equally to bantams and waterfowl, where applicable.
- 11. Care & Handling Practices Poultry must be cared for by the 4-H member. The superintendents are not responsible for daily care (feed is provided).
- 12. Champion Award Categories may vary year to year based on the number of entries. This will be at the discretion of the Small Animals Committee.

Eligibility

<u>Youth for the Quality Care of Animals (YQCA)</u> – Nebraska 4-H requires all youth enrolled in livestock projects to complete annual assurance training. In Cherry County, YQCA must be completed by the pre-fair entry deadline. This year's deadline is July 14th, 2023.

G070015 - One (1) dozen white eggs

G070016 – One (1) dozen brown eggs

Rules

- 1. Eggs will be judged on shape, color, and weight uniformity. Please do not refrigerate eggs prior to checking the eggs.
- **2.** 4-Hers are limited to exhibiting one (1) dozen of either brown, white, or other colored eggs.

Poultry Showmanship

Nebraska State Fair has lowered the age of eligibility to 9 for livestock shows. The age groups listed below are for Cherry County Fair ONLY. Please refer to the <u>State Fair Book</u> for additional details.

Class

G07001L – Junior Showmanship (8 – 10 years old by January 1 of the current year)

G070018L – Intermediate Showmanship (11 – 13 years old by January 1 of the current year)

G070019L – Senior Showmanship (14 years and up by January 1 of the current year)

Rules

- **1. Showmanship Entry** All 4-H Exhibitors are automatically registered but not required to show in Showmanship. Exhibitors must show their own animals.
- 2. Basis for Judging Showmanship is based on the grooming and training of the bird and the appearance and behavior of the exhibitor. The exhibitor must vocally explain the steps in their routine and the merit of the bird. Showmanship is the skill of the exhibitor in presenting and explaining the bird before the judge. The excellence of the bird is not considered in the scoring.
 - **1. Questions** The judges may or may not ask questions of the exhibitor at the close of the routine.
