

2025 4-H & FFA Animal Identification Guidelines/Check List for Saline County Fair, State Fair and Ak-Sar-Ben Entry

Animals MUST be officially identified for (County Fair, State Fair & Ak-Sar-Ben). This includes 4-H, FFA, and Clover Kids animals.

Identification, DNA, and nomination do not serve as an entry. Entry is an additional step required to exhibit your animals.

State Fair:

Market Animals, Breeding Animals AND Feeder Calves MUST have DNA on file at Extension Office, be nominated, paid for, and submitted via www.showstockmgr.com by the exhibit or family on or before the June 13th deadline. Entry deadline for animals is for Aug. 10 by 8 pm CST

Age requirement: State Fair: Must be 8-18 years of age as of Jan. 1 of current year.

Ak-Sar-Ben:

Market Animals, Breeding Animals, AND Feeder Calves MUST have DNA on file at the Extension Office no later than June 13 and complete online nomination. Entry deadline TBA.

Age requirement: Must be 9-19 years of age on Jan. 1 of current year.

If only exhibiting at Ak-Sar-Ben and not State Fair, you must request DNA envelopes from Ak-Sar-Ben, not the Extension Office.

FFA members should visit with your chapter advisor or State Fair FFA website for ID questions.

YQCA course completion certificates for 4-H and FFA members ages 8-21 as of Jan. 1 of current year are due at the Extension Office by June 15 for exhibitors of Beef, Goats, Sheep, Swine, Poultry & Rabbits planning to exhibit at the county fair and state fair.

BREEDING ANIMALS - June 13 Deadline Identification Requirements

Breeding Beef (Registered) – If no reg. papers at county fair the animal will show as commercial.

County Fair : Tattoo matching registration papers, [County Fair ID Card](#) & entry.

Junior Breeding Heifers must have tattoo and registration papers.

State Fair: Tattoo matching registration papers, DNA, www.showstockmgr.com nomination & entry

Ak-Sar-Ben: Tattoo matching registrations papers, DNA, online nomination & entry

<p>FEEDER CALF – JUNE 13 Deadline ID Requirements: County Fair: EID tag, County Fair ID Card & entry State Fair: EID tag, DNA, www.showstockmgr.com nomination & entry Ak-Sar-Ben: EID tag, DNA & entry</p> <p>Feeder Calves must be born between January 1 and June 15 of the current year.</p> <p>Young breeding heifers may be double nominated for County Fair & State Fair as both a feeder calf and a breeding heifer but can only be shown in ONE class and ONE division. You choose at online entry time.</p> 	<p>NOTES: All Market & Breeding animals and Feeder Calves MUST have A DNA envelope on file at the Extension Office by June 13 if planning to exhibit at State Fair or Ak-Sar-Ben. Families need to come to the Extension Office to pick up DNA envelopes.</p> <p>All State Fair Market & Breeding animals & Feeder Calves MUST be nominated in showstockmgr.com by June 13 to be eligible for entry into the State Fair. Nominations do not serve as an entry as entry is a separate process.</p> <p>If exhibiting at Ak-Sar-Ben ONLY (not state fair), the family must order DNA envelopes directly from Ak-Sar-Ben in enough time to complete and return them to Ak-Sar-Ben by their deadline.</p> <p>Premise ID – A Premise ID MUST on file at the Extension Office for any exhibitor who has animals with EID tags or Scrapie tags. More information about Premise ID is found in the next column to the right. For the Premises Type, choose “Production Unit.”</p> <p>An animal may be identified in 4-H in ONLY ONE COUNTY. An animal cannot be exhibited in 4-H or FFA in more than ONE COUNTY FAIR.</p>		<p>Age Requirement: 4-H: A 4-H animal owner/exhibitor 8 to 18 years old on January 1 of the current calendar show year is eligible to exhibit in 4-H sponsored events. Exhibitors who are 8 or older as of January 1 of the current calendar show year may exhibit at the State Fair.</p> <p>4-H Clover Kids (ages 5-7 as of Jan. 1 of the current) who are officially enrolled in 4-H can identify animals of their own to exhibit in open class/clover kid fair classes (non-competitive).</p> <p>FFA: Only bona fide Nebraska FFA members shall be eligible for FFA Division entries.</p> <p>Animal Ownership: All beef, goats, sheep, and swine must be owned: a) solely by the 4-H exhibitor or FFA member b) the exhibitor in partnership with another member (s) of his/her immediate family (can be in the name of the parent). Immediate family is defined as members of a household, including parents, brothers, and sisters, and youth in the care of the head of the household.</p> <p>Registration Papers: MUST show exhibitor’s name or a co-owner who is an immediate family member of the exhibitor’s family and is listed in the online nomination in www.showstockmgr.com</p> <p>Animal Identification: FAMILY RESPONSIBILITIES 4-H/FFA families will tag, tattoo, identify and/or DNA sample and online nominate their own animals for exhibition at county and state levels.</p>
<p>COW CALF AND COW/CALF (limit 1 pair) – JUNE 13 DEADLINE County Fair: County Fair ID Card, Tattoo for registered cow, commercial cow can have either EID or tattoo; EID tag for calf & entry State Fair (FFA only): Tattoo for cow; EID tag for calf, DNA, www.showstockmgr.com nomination & entry Ak-Sar-Ben: NO Class</p>  <p>The calf from the cow/calf pair can also be identified on the feeder calf ID form or a Breeding ID form (if female) for county fair and also entered appropriately as a feeder calf or Junior Breeding Heifer (born Jan. 1 – April 30, 2024). Can not enter for county fair as both a feeder and Junior breeding heifer. You must choose at online entry time. No changes at check-in.</p>
