Minutes from the Plant Fair and Monthly Meeting

Northeast Nebraska Extension Master Gardener Plant Fair Committee Minutes

December 13, 2025

Brian Mandl called the meeting to order.

Brian asked if the committee wants to keep fee for vendor booth rentals the same this year or raise the price. It was decided to keep the fee the same because a higher fee might deter vendors. Robin Jones moved to keep prices the same with 2nd by Kathy Duval. Motion was passed.

<u>Café</u>—Mary Lux reported that she or Linda Douglas will buy hamburger when it is on sale. A discussion was held regarding how many bars are needed to sell in the café and how much money should be donated if members don't provide bars. It was also brought up the possibility of providing a sign up sheet for donation of bars, donation of money, paper supplies, and food. We will discuss this at the January meeting.

Advertising—Robin Jones reported she foresees no change in advertising this year. Wayne Ohnesorg reported he has access to free advertising on WJAG radio every Monday. Brian Mandl inquired about if the group thought we needed more banners for advertising and where to place banners. There were 4 banners used last year. It was proposed to purchase 2 more banners. Robin Jones moved that 2 more banners be purchased, 2nd by Joyce Eucker. Motion was passed. The group will discuss at the next meeting where these banners will be placed. Deb Daehnke made the suggestion of swapping advertising with the Bargain Byway. She said this was done in the past with the intent to benefit the Bargain Byway and the Master Gardener's Plant Fair. This subject will be discussed at the next meeting.

Meeting minutes from November 2025 were approved with motion by Robin Jones and 2nd by Karen Zierke.

Treasurer's report—Connie Dvorak was absent to present Treasurer report but left information with Kathy Duval. Checking balance-\$10,200.71. \$200 in dues were deposited. \$26.06 paid for meeting supplies. Nursery stock distributors license (\$140.00) is due by 12/31/25. She will pay this next week. Please pay your dues if you haven't done so. Connie also reported that she has sent an e-mail to Shamrock Nursery about supplying annuals for the Plant Fair. She will let us know at the next meeting.

Old Business-

There was a picture in the Norfolk Daily News about the Parade of Trees with our Master Gardener decorated tree featured. The committee did another fine job this year. Brian Mandl presented a Thankyou from the Norfolk Arts Council for our participation.

Extension Garden-

Wayne Ohnesorg reported that he has spoken with Ellen Glanzer's daughter and that a donation from the family will be run through the University of Nebraska Foundation. The money would be noted to be used by Madison County Extension. Scott Beckman has offered to supply all the compost for the garden, which would replace the costly potting soil for the raised beds. In January there will be a list of plants needed for the garden so members know what plants to start from seed. There well also be a sign up sheet for labor needs.

Elkhorn Valley Museum—It was suggested by Robin Jones that the Master Gardener sign at the Elkhorn Valley Museum by removed since the group has not been helping with the garden.

Seed library—Viola McShannon stated she is currently applying for seed donations from several suppliers. She said she has many seeds currently and is asking for assistance to sort and package the seeds. There will be a signup sheet in January.
