#### ADAMS COUNTY FAMILY AND COMMUNITY EDUCATION SCHOLARSHIP RULES

# What scholarships are offered?

The Adams County Family and Community Education Clubs have established two \$500.00 scholarships.

The scholarships listed are good at any college, technical college or nursing school in or out of state. (New in 2024)

# Who is eligible?

Any high school senior with sufficient credits for college entrance can apply if:

A. The applicant must be a resident of Adams County,

<u>OR</u>

B. a member of an Adams County 4-H club (if not an Adams County resident),

<u>OR</u>

C. a son or daughter of an active member of an Adams County Family and Community Education Club (if not an Adams County resident).

#### How will the recipients be selected?

- 1. A scholarship selection committee of three disinterested persons will review the application form.
- 2. Applicants will appear before the selection committee for personal interview in the evening on the week of April 8<sup>th</sup>. This is a required element of the selection process.

#### Three letters of reference will be needed.

The letters of recommendation should include information about the applicant's character, leadership ability and why the applicant is deserving of the scholarship.

These reference letters need to be submitted with the application.

The letters should come from:

- 1. Superintendent, Principal or Class Counselor of the high school from which the applicant is currently graduating.
- 2. Two letters from representative citizens (not relatives)

## Where may one obtain Application blanks?

Application blanks for Adams County Family, Community and Education Club's Scholarship are available at any Adams County High School or at the Nebraska Extension - Adams County Office in person or on website <a href="https://go.unl.edu/adams-fce">https://go.unl.edu/adams-fce</a>.

If extra space is needed to complete the sections of the application, please attach additional sheets of paper.

## How will the scholarship be paid?

One half of the amount of the scholarship will be paid at the beginning of each semester, for one year, after he or she has passed entrance exams and enrolled in a course of study leading to his/her major.

It is understood that if tuition fees exceed the total scholarship, the recipient makes up the balance of the tuition.

## When are Applications due?

All Applications for the scholarship are to be in the Nebraska Extension-Adams County Office, P.O. Box 30, Hastings, NE 68902-0030, **before 5:00 p.m. on Friday, April 5 2024.** 

Applicants will be judged during the week of **April 8, 2024**. Applicants will be informed of the time to appear before the selection committee for a personal interview. **The personal interview is a required element of the scholarship selection process.** Not participating in this segment will be an automatic loss of 25 points. The recipients and alternates of the scholarships will be notified by the Spring Tea Scholarship Committee. Only the winners are expected to attend the Spring Tea for public recognition on **Tuesday, April 23rd at 7:00 PM at the Nebraska Extension office – 2975 S Baltimore Ave**.

#### When does the scholarship need to be accepted?

The recipient must notify the Adams County Extension Office of his/her acceptance of the scholarship by June 1, of the year it is received.
