# 4-H and FFA Animal Exhibitor and Animal Project Regulations

# Age of Exhibitor

**4-H** — A 4-H animal owner/exhibitor 8 to 18 years old on Jan. 1 of the current calendar show year is eligible to exhibit in 4-H-sponsored events. Exhibitors who are 10 as of Jan. 1 may exhibit at the Nebraska State Fair. 4-H members may be certified for state and interstate shows if they meet age requirements for that event and have properly enrolled animals.

**FFA** — Only bona fide Nebraska FFA members aged 12-21 shall be eligible for FFA Division entries. There will be no discrimination because of race, color, sex, religion, or national origin.

### **Animal Ownership**

All beef, swine and sheep project animals must be owned:

- a) solely by the 4-H exhibitor, or
- b) the exhibitor in partnership with other member(s) of his or her immediate family. Only the name of the showman can be on the show entry. Immediate family is defined as members of a household, including parents, brothers and sisters, and youth in the care of the head of the household.

# **Registration Papers**

For the Nebraska State Fair, registration papers must show one of the following:

- a) the member's name as owner, or
- b) the name of the exhibitor and/or a co-owner who is a member of the exhibitor's immediate family (see immediate family definition above), or
- c) the family farm or ranch name or parent's name.
