



# **Brand Inspection & Bill of Sale Packet**

Dear 4-H & FFA Families,

Over the past few years we have had some issues with obtaining **CORRECT** & **COMPLETE** Brand Papers or Bills of Sale for market beef projects. This issue needs to change and be resolved. Improperly filled out documents will no longer be accepted. The Livestock Committee has provided this brand paper & bill of sale packet for your convenience. Please look this over if you are planning on showing market beef or participating in the carcass contest.

Brand papers and bills of sale should be filled out properly in the exhibitor's name. This is important as this is their proof of ownership.

Bills of sale need to have: name and address of seller, name and address of exhibitor (buyer), headcount and description of animal or animals, description and location of brand(s) or list no brand (NB) if there isn't one. The Bill of Sale also needs to be signed by the seller and signed by a witness that is a third party, excluding minors (the witness must be of legal age), and the document must be dated.

Brand papers are required for out of state purchases made from states that have brand inspection laws. Examples of properly completed brand papers and bills of sale are attached. There are also blank bills of sale included for you to use when purchasing and obtaining ownership of a beef.

A computer generated receipt is not acceptable. Exhibitors need to get their proof of ownership when they purchase and take possession of the animal or animals. This is important as this is proof that they now own the animal or animals.

This year at our 2019 initial beef weigh-in and tagging, if you do not have your proper bills of sale or brand inspection paper filled out, you will not receive a 4-H tag and you will not be eligible for the rate of gain contest. However, you will have until **April 1, 2019** to show proof of ownership (brand inspection or bill of sale) of your market beef to get a 4-H tag from the Extension Office. If you have not obtained a 4-H tag or shown proof of ownership by this date, you will not be eligible to show, sell, or participate in the carcass contest in the 2019 Box Butte County Fair. These papers will be looked over by the brand inspector and verified by him. *Forged or incomplete papers will not be accepted.* Please remember this bill of sale is not just a piece of paper, it is a legal and binding document, which if altered can be punishable by law.

A few things I want to bring to your attention.

- First, if you purchase a market beef from someone, when you go to pick it up and pay for it, take a bill of sale with you so the seller can fill it out right there.
- Second, if you buy a market beef online, make sure that the seller is aware that you need a bill
  of sale and have them mail you one!
- Third, if you choose to buy a market beef online, it is **YOUR** responsibility to get the correct proof of ownership for your animal.
- Lastly, make sure that the animal is in the exhibitor(s) names and not the parent's name (if you have more than one exhibitor list all their names as the owner).

A few changes will be put into place this year:

- As mentioned above, you must have completed bill of sale or brand inspection paper present at the January Market Beef Weigh-in to receive a 4-H tag.
  - You will have until April 1, 2019 to show proof of ownership to the 4-H Office to obtain your 4-H tag, if you do not have a tag by this date you will not be eligible to show or sell market beef or participate in the carcass contest in the 2019 Box Butte County Fair.
- YOU will be responsible for your brand inspection or bill sale paper. You must present your paper as proof of ownership, but the Extension Office WILL NOT keep those papers this year.
  - You will be required to bring them the final weigh-in before fair to give the brand inspector.
- The brand inspector and Nebraska Brand Committee will no longer accept computer generated receipts as a bill of sale.

The reason for this packet is to help you as parents and exhibitors to learn and to help our fair run smoothly. Also, we want to keep the integrity of our livestock show and sale. If we have improper brand papers or bills of sale, that disgraces the name of our Box Butte County Fair and Sale.
