





#### **Rules and Regulations 2018**



#### **General Show Information:**

- Open to all 4-H and FFA members.
- Exhibitors must be at least 8 and no more than 18 years old before January 1, of the current year.
- The Show Committee will have the final decision on class breaks and registration paper discrepancies.
- Please bring your own bedding and clean up before leaving.
- Dress: Show attire 4-H/FFA shirt not required. NO halter tops or sleeveless shirts/blouses.

#### **Classes:**

• Showmanship: All ages before January 1, of the current year.

Senior Division - 14 and older; Intermediate Division - 11-13; Junior Division - 8-10.

Clover Kids - 5-7 (non-competitive and sheep / goats only).

#### • Sheep & Meat Goat Show Information

Show order: Sheep and Sheep Showmanship followed by Goat and Goat Showmanship

#### **Meat Goats:**

- ⇒ All meat goats must have a scrapies identification tag. Meat goats will be shown by weight. No re-weighs.
- ⇒ Goats are to have milk teeth and there shall be no evidence of breaking of the skin or eruption of the two permanent front teeth.
- $\Rightarrow$  Goats must have horns blunted.
- ⇒ Goats are to be shown with neck chains or smooth collars only.
- ⇒ Market goats may be doe or wether kids.
- ⇒ Short scrotum, cyptorchid and buck kids are not eligible.
- ⇒ Does and wethers will show together.
- ⇒ No Dairy Goats.

#### **Market Lambs:**

- ⇒ All market lambs must have a 4-H or FFA identification tag.
- ⇒ Market lambs will be shown by weight. No re-weighs.

#### • Beef Show Information

Show Order: Breeding Heifers, Market Heifers/Market Steers, Showmanship

#### **Breeding Heifers:**

- $\Rightarrow$  Heifers must be born between 9/1/16 and 12/31/17.
- ⇒ Heifers will be shown by breeds.
- ⇒ All registration papers or breeders certificate must be presented at check-in.
- ⇒ Heifers without papers will show in the commercial class.
- $\Rightarrow$  All breeding heifers must be identified by legible ear tattoo(s).

#### **Market Heifers/Market Steers:**

- $\Rightarrow$  All market animals must be born in 2017.
- ⇒ All Market Steers and Heifers will be shown by weight.
- ⇒ All market beef must have a current Nebraska 4-H or FFA ear tag in place to be eligible to show.
