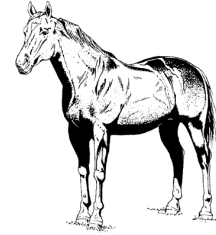


## 4-H Invitational Horse Show Buffalo County Fairgrounds Kearney, Nebraska Sunday, July 7, 2024

Age Divisions (as of January 1 of the current year)

3 Divisions – 8-11 (Div. 1), 12-14 (Div. 2) and 15-18 (Div. 3)

**All classes start with the senior division.**

**Show order: Seniors (Div. 3), Intermediate (Div. 2), Juniors (Div. 1)**

**\*Classes DO NOT count towards high point awards. High Point is Showmanship +5 classes of your choice. SMS is the tiebreaker class. One horse, One rider for each high point bid.**

### Classes

1. English Pleasure (3 age divisions).
2. English Equitation (3 age divisions).
- 15 Minute Break**
3. Showmanship (3 age divisions starting with seniors).
4. Walk -Trot (Level 1 Riders All Ages – Only eligible to participate in riding classes 12, 13).\*
5. 2 & 3 Year Old Western Pleasure – Showing together but judged separately.
6. Western Pleasure (3 age divisions).
7. Ranch Horse Pleasure Level II Riders and above (1 age division).
- 30 Minute Lunch Break**
8. Trail (3 age divisions).
9. Western Horsemanship (3 age divisions).
10. Ride- A- Buck \* **No entry fee. Bring your own dollar. 50% split the pot to the winner.**
11. Reining (3 age divisions).
12. Pole Bending (3 age divisions).
13. Barrel Racing (3 age divisions).

If speed events are held indoors, Keyhole Race will be held instead of Barrels.
