4HOnline is now open to take 4-H enrollment for the 2019 fair season at <https://ne.4honline.com>. Clubs and projects are cleared out for each individual so you will be starting from scratch. After the March 1 deadline, a \$10 late fee will be added for each member until April 1 which is the final enrollment deadline.

Any youth who are interested in competing at the Horse Stampede in Lincoln on March 30, please let the extension office know. The Horse Stampede contests include quiz bowl, demonstrations, public speaking, art and photography. A parent is required to call the office to register their child for any of the events. Registrations are due to the extension office by noon on March 1<sup>st</sup>. If you would like a Horse Stampede shirt, the cost is \$5 and must be paid by March 1<sup>st</sup> (no youth sizes).

Scotia will host the Central IV contest day on March 23 at 9 am for public speaking, presentations, favorite foods and the culinary challenge. Please register your events with the extension office by March 15. We will need the 4-H'ers name, age, title of speech or presentation.

A Nebraska 4-H Shooting Sports Leader Certification Workshop is scheduled for April 6-7 at the Merrick County Fairgrounds in Central City. The deadline to register for the Central City training is March 27<sup>th</sup>. Volunteers have the opportunity to become certified as an adult (21 years and older) or apprentice (14-20 years old) leader. Six project areas will be offered at the Workshop - rifle, shotgun, and archery. The registration fee is \$110.00 per person for initial certification and those individuals adding an additional discipline and \$90 for apprentice training. This fee includes meals, supplies and program materials. The registration fee after March 27<sup>th</sup> is \$160. Participants must make their own lodging arrangements. Registration on Saturday runs from 8:00 a.m. to 8:45 a.m.

For animals to compete at State Fair/AkSarBen, they must be nominated at [www.showstockmgr.com](http://www.showstockmgr.com). You will pay a \$7 fee online for market animals and there is a \$2 online fee for breeding animals. The fees are to be paid online. Nebraska will be hosting the 4-H Shootings Sports National Championships at the Heartland Public Shooting Park and Events Center in Grand Island on June 23-28, 2019. Nebraska is still seeking eligible youth interested in participating in the 2019 4-H Shootings Sports National Championships in the following discipline areas – smallbore rifle, smallbore pistol, air pistol and muzzleloading. 4-H youth who are interested in participating in one or more of these discipline areas are required to

Deadline to complete the online Interest/Intent Form is March 1, 2019. Participants will be notified by one of the Nebraska coaches with more details after the deadline.

Registration is now open for 2019 summer camps! New in 2019, the Eastern Nebraska 4-H Center will be exclusively offering weeklong day camps for youth ages 6-15. Additionally, chartered transportation will be available from Gretna and Grand Island for several camps at the Nebraska State 4-H Camp in Halsey. The 2019 Nebraska State Fair Culinary Challenge will be Saturday, August 31. 4-H youth 10-18 years old are eligible to compete in teams of 2. The challenge ingredient this year is dairy. For more information go to <http://food.unl.edu/4-h-food-projects>.

Any youth ages 8-18 who will be showing beef, sheep, swine, goats, market broilers or market fryer rabbits will need to either attend a YQCA training or go online to do their training at <https://yqca.learn-grow.io/account/login>. Instructions on how to sign up for all the trainings are posted at <https://extension.unl.edu/statewide/central4/yqca-quality-assurance-training/>. Age breaks for 4-H kids are as follows: junior 8-11, intermediate 12-14, senior 15-18. Youth must be registered in 4-H before you will be allowed to register for the YQCA training.

Nebraska Extension and the Nebraska Corn Board are offering the seventh Innovative Youth Corn Challenge contest. This contest, open to 4-H members (age 10 & older as of Jan. 1st) or FFA members (in-school members), guides participants through all aspects of corn production, as well as agricultural careers related to corn production. As a team (2 or more participants), youth will be challenged to implement a production practice different than normal to determine if they increased their yield. Economics and sustainability of the practice will also be considered. Yields, cropping history, and production information will be collected in the Corn Yield Challenge management summary. Cash prizes and plaques are given. First place receives \$1,000, second place receives \$500, and third place receives \$250. Sustainability, crop scouting and “extra mile” awards are also given as cash awards. To participate in 2019, youth must complete and return an entry form by March 15<sup>th</sup> to the Fillmore County Extension Office in Geneva, NE. Through [Farm Credit Services of America's Working Here Fund](http://www.fcsamerica.com/workingherefund), organizations in Nebraska can apply online for community involvement grants. Grants are awarded of up to \$2,000 and \$10,000 each for projects and organizations that make a positive, long-term impact in the areas of Agriculture Education, Young and Beginning Producers, and Hunger and Nutrition. Applications can be completed online at [www.fcsamerica.com/workingherefund](http://www.fcsamerica.com/workingherefund). Grants are determined based on the specific selection criteria. The second grant application period for the \$2,000 grants will run January 1 through March 31, 2019, and the \$10,000 grant application period will run January 1 through June 30, 2019.

Ord will host a **district horse show** June 12, 2019

The Aksarben Stock Show will transition to junior livestock show format in 2019. Under the junior show model, youth from nine to 19 years of age are eligible for the competition with no prerequisite of youth organization affiliation. This allows for more junior exhibitors to show at Aksarben. Rules for the 2019 event will be written by Aksarben Stock Show management, versus the previous system of rules within each state operating independently.
