1. One bona fide identified 4-H project horse (identified and enrolled as a project in the Extension Office by June 15) per exhibitor will be stalled at the county fair from entry time until the announced dismissal time.
2. The 4-H Horse Superintendent will be notified at entry time, or in case of emergency, if any changes are necessary.
3. **All exhibitors must have completed Horse Advancement Level 1 to compete in fair events.**
4. **Only members are allowed to ride horses during show times. Adults may not warm up horses.**

I have read, understand and agree to comply with these rules. I also understand that if these rules are broken, I will lose any premium earned in the horse project at the Clay County Fair.
