**Family Responsibilities:**

1. Exhibitors will be required to enroll in 4-H and the required projects by the county deadline in 4H Online.
2. Exhibitors showing market animals at State Fair must have a signed and sealed official DNA envelope with hair samples for DNA verification turned into their county office and have completed the online nomination ([www.showstockmgr.com](http://www.showstockmgr.com)) along with submitting payment online by June 14. Any animal carrying an 840 EID tag will require the exhibitor to obtain a Premises ID. Contact the local Extension Office for details. (It is recommended that you make a copy or a photo image of completed envelope you turn into your county.)
3. Exhibitors showing breeding beef, breeding sheep and breeding goats at State Fair must have a signed and sealed official DNA envelope with hair samples for DNA verification turned into their county office and have completed the online nomination ([www.showstockmgr.com](http://www.showstockmgr.com)) along with submitting payment online by June 14. Any animal carrying an 840 EID tag will require the exhibitor to obtain a Premises ID. Contact the local Extension Office for details. (It is recommended that you make a copy or a photo image of completed envelope you turn into your county.)
4. Exhibitors will be required to complete Youth for the Quality Care of Animals (YQCA) for the enrolled livestock projects by the county deadline.
5. Exhibitors will notify the County Extension Staff of any retags that may occur up to time of check-in at the State Fair.
6. Exhibitors will select which animal nominations they have chosen to show at State Fair on the State Fair entry website. All nominated and validated animals will be automatically listed as a choice option for entry registration.
7. Exhibitors will be required to bring the breed registration association paperwork to check-in at State Fair for animals wanting to show in a breed class. The registration papers must show the exhibitor's name, a co-owner who is an immediate member of the exhibitor's family or the family farm, ranch name or parent's name.

## 4-H Animal Exhibitor and Animal Project Regulations

**Age of 4-H Exhibitor**

A 4-H animal owner/exhibitor 8 to 18 years old on Jan. 1 of the current calendar year is eligible to exhibit in 4-H sponsored events. Exhibitors who are 8 as of Jan.1 may exhibit at the State Fair. 4-H members may be certified for state and interstate shows if they meet age requirements for that event and have properly enrolled animals.

**Animal Ownership**

All beef, swine and sheep project animals must be owned:

- a) Solely by the 4-H exhibitor or
- b) The exhibitor in partnership with the other members(s) of his or her family. Only the name of the showman can be on the show entry. Immediate family is defined as members of a household, including parents, brothers and sisters, and youth in the care of the head of the household.

**Registration Papers**

For County Fair, State Fair, and Aksarben, registration papers must show one of the following:

- a) the member's name as owner, or
- b) the name of the exhibitor and/or a co-owner who is a member of the exhibitor's immediate family (see immediate family definition above), or
- c) the family farm or ranch name or parent's name
- d) registration must be completed by fair date

**Identification of Animals**

- a) All animals must be individually identified, listed on the appropriate 4-H form and on file in the local extension office.
- b) An animal may be identified in only one county.
- c) An animal cannot be shown in more than one county.
