LIVESTOCK/HORSE I.D. DEADLINES



- **June 1** State 4-H Horse Show Deadline for Online Entries, ID's, and Advancement Levels. Deadline for all 4-H Horse ID's for county fair horse entries
- June 15 Deadline for eartagging meat goats, breeding heifers, market swine, stocker-feeders, bucket calves, and submitting ID sheets to the Extension Office. Rabbits, dairy cattle, and dairy goats must also be identified. Identification forms are available at the Extension Office. (Clover Kid bucket calves DO NOT need identification forms or eartags.)
- June 15 For State Fair Exhibitors showing market and/or breeding beef, feeder calves, market and/or breeding swine, market and/or breeding sheep or market and/or breeding goats at State Fair must have a signed and sealed official DNA envelope with hair samples for DNA verification. Every animal nomination (this includes all breeding animals and feeder calves) will require a DNA submission. DNA must be turned into their county office and have completed the online nomination with payment in Show Stock Manager by June 15. Any animal carrying an 840 EID tag will require the exhibitor to obtain a Premises ID. Contact the local Extension Office for details. (It is recommended that you make a copy or a photo image of the completed envelope you turn into your county.)

4-H Organizational Leaders may make one (1) eartag order for the club or families may stop by the Extension Office to pick up their own eartags. To submit your order, the order form may be emailed, mailed, or delivered in-person.

CUSTER COUNTY YOUTH ANIMAL QUALITY ASSURANCE TRAINING



Nebraska Extension in Custer County is once again partnering with Adams Land and Cattle to hold an exciting and interactive Youth Quality Assurance Training the **evening of Wednesday, June 14. This will be an in-person event held at the Municipal Building in Broken Bow.** Any Custer County 4-H member (4-H age 8-18) or FFA member who plans to show sheep, beef, swine, dairy, rabbits, poultry, and/or goats at the Custer County Fair, Nebraska State Fair, and/or Aksarben needs to be trained for Quality Assurance. **YOUTH WERE REQUIRED TO REGISTER FOR THIS EVENT BY MAY 17.**

Schedule of Events for Wednesday, June 14:

- -Registration begins at 6:15 p.m. at the Broken Bow Municipal Building, 314 So. 10 Avenue.
- -The program will begin at 6:30 p.m. and will last approximately 1.5 hours.
- -Parents may pick up participants at 8:00 p.m.

During the training, youth will move through a series of stations to educate them on Animal Quality Assurance.

*With the changes in quality assurance going to a national training program called Youth for the Quality Care of Animals (YQCA) there is a \$3 fee/participant for face-to-face trainings. This fee is being paid by Adams Land and Cattle. After the training each participant will be given a coupon with a code that will then need to be entered into the YQCA website. This coupon code will cover the \$3 fee. Instructions for entering the required information for YQCA will be emailed to participants following the training along with the coupon code.

YOUTH WHO DID NOT REGISTER FOR THE JUNE 14 EVENT, OR WERE NOT ABLE TO ATTEND THE IN-PERSON TRAINING ON JUNE 14, WILL NEED TO COMPLETE THE ONLINE QAUALITY ASSURANCE TRAINING COURSE BY JUNE 15 AND PRESENT THE COMPLETION CERTIFICATE TO THE EXTENSION OFFICE.

COUNTY FAIR LATE ENTRIES

4-H entries must be made according to the printed 2023 Custer County Fair Premium Book and entered online by 5:00 p.m. on June 30. Instructions for online entries will be emailed to 4-H families on approximately May 15. At the September 19, 2022 4-H Council meeting, the following motion was made. "Every 4-H member is eligible for a "one-time" member exemption for late county fair entries. The exemption provides the ability (one-time in a 4-H member's career) for the 4-H member to acknowledge they missed the county fair entry deadline, with a \$25 late fee charged per member."

ONLINE FASHION SHOW NARRATIVES

All 4-H'ers entering the fashion show must have all typed or clearly printed fashion show narratives in to the Extension Office by 5:00 p.m. on Monday, July 17. Narratives should take approximately 30 seconds to read out loud.



4-H'ers are strongly encouraged to submit their narratives online. The link to submit narratives is: https://goo.gl/forms/XmH2NAirqXtODBxr1.

Narratives may be submitted online at the link <u>OR</u> submitted in paper form to the Extension Office. The deadline for narratives is 5:00 p.m. on Monday, July 17. If you wish to edit your narrative submitted online, please be sure to click on the



"Edit Your Response" link at the end of the submission, instead of creating a new narration. Please do not email narratives to Extension Staff. 4-H'ers who do not turn in a narrative cannot model in front of the fashion show judge and cannot participate in the public fashion show. All 4-H'ers who model in front of the fashion show judge MUST model at the public fashion show. This includes all sewing, knitting, crocheting, and consumer management projects.

4-H & FFA LIVESTOCK AUCTION

To partially offset costs associated with the 4-H & FFA Livestock Auction, the Ag Society will be charging a fee of \$10 for every beef that sells through the ring and \$2 for every sheep, swine, and goat that sells through the ring. This fee is in addition to the charges for brand inspection, check-offs, and promotional fees for advertising costs and framed photographs of champions.

Each exhibitor will be permitted to sell only **ONE ENTRY** at the sale. For example: an entry is one market beef, one to three lambs, one to three market hogs, or one to three meat goats. Exhibitors can sell only 4-H or FFA animals and not a combination of the two at the Livestock Auction.

The 4-H & FFA Livestock Auction will be held on Thursday, August 3 beginning at 7:00 p.m. at the show ring on the Custer County Fairgrounds. The sale order will be...BEEF - SWINE - SHEEP - GOATS.

2023 CWF CONCESSION STAND WORK NIGHT AND INFORMATIONAL MEETING



A 2023 CWF Concession Stand Work Night and Informational Meeting will be held Tuesday, July 18. The purpose of the meeting is to clean the concession stands in preparation of county fair, to discuss county fair concession stand procedures, and get acquainted. All delegates and at least one parent are encouraged to attend. Everyone should plan to meet at the 4-H Building at 6:00 p.m. to receive their cleaning assignments. A sloppy joe supper will be served at approximately 7:30, with an informational meeting to follow.

NOTE TO 4-H CLUBS WHO USE THE SHOOTING SPORTS BUILDING (BUILDING 18) AT THE FAIRGROUNDS

The Custer County Ag Society voted at their February 10, 2011 meeting to ask all 4-H clubs who use the Shooting Sports Building (Building 18) at the Fairgrounds for monetary donation(s) to help defray the costs of utilities (heat, electricity, air conditioning) effective immediately. The Ag Society would also consider in-kind labor for projects at the Fairgrounds, in lieu of monetary donation(s) from 4-H clubs. FOCUS ON CHARACTER...CHARACTER AND SPORTSMANSHIP!

Friends, colleagues, employers, award committees, and judges look for people who have good character. Long after people have forgotten that you were Grand Champion showman at the county fair, they will remember your reputation and character. You may never get a blue ribbon for your fairness, trustworthiness, or citizenship, but character "Does Count!"

Your Character = You

Sportsmanship is character applied to competitive settings. Good sportsmanship isn't reserved for the show ring. It should happen before, during, and after a show! Good sportsmanship applies to all 4-H'ers, not just those with livestock. 4-H'ers should also display good sportsmanship at the fashion show, interview judging, shooting competitions, judging competitions, etc. Someone who is "a good sport" shows that they are a person of character.

- Follow all rules.
- ▶ Be ethical.
- ▶ Be honest.
- ▶ Do not cheat.
- Accept the ruling of judges and referees without complaining.
- ► Keep your promises.
- ▶ Dress correctly for each situation.
- Exhibit your own work.
- ► Treat others with courtesy and respect.
- ► Treat your animals with kindness and respect.

THE LEO C. COOKSLEY MEMORIAL AWARD

The Leo C. Cooksley Memorial Award will be presented annually to a person who best demonstrates those qualities of Leadership, Citizenship and Courage that were exemplified by Leo C. Cooksley and demonstrated at the 2023 Custer County Fair. Be thinking of someone who you might like to nominate. Prospective recipients need to be submitted to the Nebraska Extension - Custer County Office by Friday, September 15th. Nomination forms will be available at the Extension Office or in the Livestock Office during the county fair.

SHEEP & SWINE

Sunday, July 30, sheep and goats will be weighed at the county fair 2:30-3:30 p.m. and hogs will be weighed 4:00-6:00 p.m. Immediately following weigh-in, the pens, catch pens, and alleys must be constructed. When the sheep show is over, the pens are taken down to make room for the beef show on Tuesday. These are big jobs. 4-H and FFA swine families are asked to help construct the pens and alley immediately following weigh-in on Sunday. 4-H and FFA sheep families are asked to take the pens in the show ring down immediately following the sheep show. People who have done this in the past will be there to

Only 4-H market beef animals identified in February will be eligible for the carcass contest, awards, and premium money. A brand release must be available before the calves will be loaded. The brand inspector will check all calves in the usual customary manner at load out time. Lack of a brand release may result in delayed payment.

BUILDING SITTERS

The Building Sitter schedule for 4-H Clubs is included below with this Bow Knot issue. Each time slot has only one club listed. The club that is listed is responsible for watching the Hall of Champions (4-H Building) and the 4-H Exhibit Hall during that time. Both buildings will need at least one building sitter at all times. If the assigned time does not work for your club, please trade with another club. The Extension Office will not find a substitute. The building sitter can be a 4-H member, parent, grandparent, neighbor...anyone. The purpose of the building sitters is to make sure the exhibits are not tampered with, and to welcome our guests to the exhibits. Please be sure to show up at your assigned times to help ensure the security of the 4-H exhibits.

DOG, CAT, AND FERRET VACCINATION CERTIFICATES REQUIRED - DUE JUNE 30!

Any 4-H member enrolled in Cat, Dog, Pets, and Animal Caretaker (Clover Kids) who will be exhibiting a dog, cat, or ferret at the county fair and/or state fair will be REQUIRED to turn in a Nebraska Certificate of Vaccination. The Nebraska Certificate of Vaccination MUST be turned in to the Extension Office by June 30 for cats, dogs, and ferrets which will be shown. These forms are available at the Extension Office and can also be printed from:

> Dog Vaccination Form Cat and Ferret Vaccination Form



Cats are required to be current on their vaccinations of rabies, panleukopenia, viral rhinotracheitis, and calicivirus. Cats must either have a current feline leukemia vaccination or proof of a negative test within 180 days of the show. Proof of vaccinations must be turned in to the Extension Office by June 30. Participants should have their veterinarian fill out and sign the "Nebraska Cat/Ferret Vaccination Record Form." Exhibitors will not be allowed to show without a signed Vaccination Record Form.

Ferrets must be vaccinated for rabies and have a completed health form signed by the administering 3 veterinarian turned in to the Extension Office by June 30. A rabies vaccination is federally mandated to be given by a Certified Veterinarian ONLY. This vaccination must be current and include a veterinarian signature on the Vaccination Record Form.





Dogs must be immunized for distemper, hepatitis, parvo, and rabies. The Nebraska 4-H Certificate of Vaccination for Dogs Form must be filled out and signed by a veterinarian, and turned in to the Extension Office by June 30. The Nebraska 4-H Certificate of Vaccination for Dogs Form must document all vaccinations within 1 year or 3 years depending on the vaccine given. All required vaccinations must be given within 1 to 3 years of the show date based on label guidelines. All vaccinations must be in effect at the time of the county fair dog show. Explanation: Some rabies vaccinations are viable for one year and some rabies vaccinations are viable for three years but are specifically designed and administered according to their label. It is not acceptable nor allowed to vaccinate a dog with a 1 year rabies vaccine and plan to have it in effect for 3 years.

Competitors need to be enrolled in the discipline they are entering AND working with a certified 4-H shooting sports leader in that discipline in order to compete at the county fair 4-H Shooting Matches. Competitors need to select the age division in the discipline they are entering and the relay times they would be available to shoot that discipline. Relays will be filled on a first come, first served basis.

Competitors must also make a county fair entry for the classes they wish to enter. 4-H entries must be made according to the printed 2023 Custer County Fair Premium Book and entered online by 5:00 p.m. on Friday, June 30.

COUNTY FAIR 4-H HORTICULTURE ENTRIES

If you are unsure of what classes you will be entering in Cut Flowers (Classes 1-46), Houseplants (Classes 60-66), Vegetables/Herbs/Fruits (Classes 201-286), you may make "blank" online entries. The actual class numbers will be filled in when the 4-H'ers come to interview judging on July 26. See the premium book for specific guidelines on pages 79-85.

For "blank" entries in Cut Flowers-Annuals and Biennials (Classes 1-23), enter **CLASS G770023 ANY OTHER ANNUAL OR BIENNIAL**. List this class number for <u>each</u> annual and biennial you wish to enter, up to the entry limit.

For "blank" entries in Cut Flowers-Perennials (Classes 30-45), enter CLASS G770045 ANY OTHER PERENNIAL CUT FLOWER. List this class number for <u>each</u> perennial cut flower entry you wish to enter, up to the entry limit.

For "blank" entries in Houseplants (Classes 60-67), enter **CLASS G770067 ANY OTHER CONTAINER GROWN HOUSEPLANT**. List this class number for <u>each</u> houseplant entry you wish to enter, up to the entry limit.

For "blank" entries in Vegetables (Classes 201-252), enter **CLASS G773252 ANY OTHER VEGETABLE**. List this class number for <u>each</u> vegetable entry you wish to enter, up to the entry limit.

For "blank" entries in Herbs (Classes 260-268), enter **CLASS G773268 ANY OTHER HERB**. List this class number for <u>each</u> herb entry you wish to enter, up to the entry limit.

For "blank" entries in Fruits (Classes 280-286), enter **CLASS G773287 ANY OTHER FRUITS OR NUT**. List this class number for <u>each</u> fruit or nut entry you wish to enter, up to the entry limit.

EXAMPLE: If you would like to have 3 blank entries for vegetables, and you only make 2 online entries, you will only be able to enter 2 exhibits on the day of interview judging.

Follow the guidelines in 4-H "Preparing Cut Flowers for Exhibits" 4H227 (revised 2016) (free download-https://unl.box.com/s/2f3a785c67p7qhqasevp6gu6adf3ugon) when preparing entries for the fair. This publication is also available at the Extension Office.

Follow the guidelines in <u>"Selecting and Preparing Vegetables, Herbs and Fruits for Exhibit" 4H226 (revised June 2013)</u> when preparing entries for the fair. This publication is also available at the Extension Office.

<u>Cultivar/Variety Names</u> - When planting your seeds or purchasing your plants, be sure to save the cultivar/variety name. This will be needed when you enter your horticulture exhibit at the county fair. Entries without cultivar/variety names, will be dropped a ribbon placing.

CWF COUNTY FAIR CONCESSIONS STANDS

- There will be CWF concession stands at the county fair this year. Additional concessions will be offered under the Grandstand on Friday, July 21 for the Lineman Rodeo and on Saturday, July 29 for the concert. Concessions will be offered during the 4-H Dog Show on July 22 at the Chuckwagon.
- There will **NOT** be charge cards at the county fair concession stands for families again this year.
- Checks must be made payable to **4-H ACTIVITIES**. Any checks returned as "Insufficient Funds," will be charged a \$30 service charge plus the amount of the original check.
- Cash payments at the concession stands are recommended. Please do not pay with bills larger than \$20, if possible.

Entry deadline is August 10 by 8:00 p.m.. This includes entries for fashion show, contests, beef, sheep, swine, rabbit, poultry, goat, dairy, and dog.
