As the State Director of the Make It With Wool Contest, I am excited to provide you with this year's Make It With Wool competition information.

The State Contest will be held November 23, 2019 at the Adams County Extension Office, 2975 South Baltimore Ave., Hastings, NE. All entries are due October 15, 2019. The entry form, state brochure and national wool contest guidelines are enclosed and also posted on the website:

***All participants must pay the wool testing fee, state entry fee and national entry fee.***

PLEASE NOTE THESE CHANGES:

- Age is determined by January 1, 2019 (national rule).
- In addition to the National and State entries fees, there is a \$7 wool testing fee per fabric swatch and/or 36 inch length of yarn, because of National requirements.
- The entry form has been enlarged and will be printed on 8.5 X 11 inch size paper. Contestants will need to print copies of the entry form.
- The size of the sample required for national entry has changed.
- Entries are mailed to Andrea Nisley, PO Box 757, Lexington, NE 68850-0757 (see brochure).

Entry forms need to be mailed as follows:

- One entry form with a \$12 check (made out to National MIWW) and one wool sample (3 X 3 inch) of each wool fabric and/or 12 inch lengths of yarn need to be sent to Lynda Johnson, National MIWW, P.O. Box 215, Encampment, WY 82325.
- Another copy of the entry form with a \$10 check (made out to Nebraska State Make It With Wool) and two wool samples (5 X 5 inch) of each wool fabric and/or two 36 inch lengths of yarn, and testing fee to Andrea Nisley, P.O. Box 757, Lexington, NE 68850.
- In addition to the National and State entries fees, there is a \$7 wool-testing fee. Include the wool-testing fee of \$7 per fabric swatch and/or yarn with the state entry fee check. All fabrics/yarns for Preteen, Junior, Senior, Adult and Made for Others Divisions must be lab tested for percentage of wool content prior to state competition.
- Keep a copy for your record.
