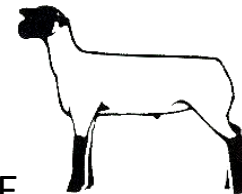
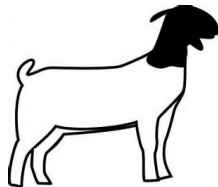

- ◆ Animals must be in good health
- ◆ All out of state animals must have health and brand papers
- ◆ All Market Animals MUST have 4-H or FFA tags
- ◆ All lambs and goats MUST have Scrapies tag
- ◆ Animal housing will be available on a first come, first serve basis. Provide own bedding and clean up after the show.

General Show Information:

- Open to all 4-H and FFA members.
- Exhibitors must be at least 8 and no more than 18 years old before January 1, of the current year.
- The Show Committee will have the final decision on class breaks and registration paper discrepancies.
- Please bring your own bedding and clean up before leaving.
- Dress: Show attire – 4-H/FFA shirt not required. NO halter tops or sleeveless shirts/blouses.
- **Health Requirements:** All livestock are subject to examination, upon arrival, for evidence of infectious or contagious diseases, open wounds and other animal health concerns. If found, animals will not be allowed entrance onto the grounds. Under no circumstances may animals under quarantine be exhibited.

Classes:

- **Showmanship:** All ages before January 1, of the current year.
Senior Division - 14 and older; Intermediate Division - 11-13; Junior Division - 8-10.
Clover Kids - 5-7 (non-competitive and animals under 350 pounds).

- **Sheep & Meat Goat Show Information**

Show order: Sheep and Sheep Showmanship followed by Goat and Goat Showmanship

Meat Goats:

- ⇒ All meat goats must have a 4-H or FFA identification tag. Meat goats will be shown by weight. No re-weighs.
- ⇒ Goats are to have milk teeth and there shall be no evidence of breaking of the skin or eruption of the two permanent front teeth.
- ⇒ Goats must have horns blunted.
- ⇒ **Goats are to be shown with neck chains or smooth collars only. (Will be enforced.)**
- ⇒ Market goats may be doe or wether kids.
- ⇒ Short scrotum, cyptorchid and buck kids are not eligible.
- ⇒ Does and wethers will show together.

Market Lambs:

- ⇒ All market lambs must have a 4-H or FFA identification tag.
- ⇒ Market lambs will be shown by weight. No re-weighs.

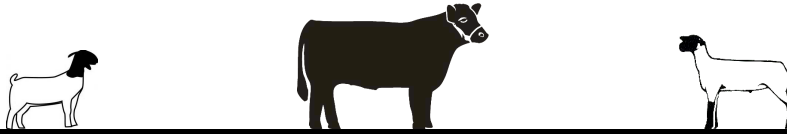
Show Order: Breeding Heifers, Market Heifers/Market Steers, Showmanship

Breeding Heifers:

- ⇒ Heifers must be born between 9/1/15 and 12/31/16.
- ⇒ All registration papers or breeders certificate must be presented at check-in.
- ⇒ Heifers without papers will show in the commercial class.
- ⇒ All breeding heifers must be identified by legible ear tattoo(s).

Market Heifers/Market Steers:

- ⇒ All market animals must be born in 2016.
- ⇒ Market Steers and Heifers will be shown by weight. If scale is unavailable, hip height will be used.
- ⇒ All market beef must have a current 4-H or FFA ear tag in place to be eligible to show.
