

## **Consumer and Family Science - Department C Clover Kids**

### **General Information:**

- A. Clover Kids 4-H projects are for youth 4-H age 5 to 7 years. 4-H age is determined by the age of the child on Dec 31, 2020.
- C. 4-H'ers are encouraged to interview judge on entry day, although it is optional.
- D. Clover Kids are not restricted to the guidelines of the fair book and may enter any age appropriate static or animal exhibits and participate in most 4-H contests. Projects in the fair book for older youth may be used as ideas for Clover Kid projects but should then be made applicable for 5 – 7 year olds. Clover Kids are not “judged” by the same standards as the older members. They receive special Clover Kid ribbons and DO NOT receive premium money.
- E. Exhibits will be on display during the county fair in the Clover Kid area.
- F. **Clover Kid projects are not eligible for State Fair.**

**Clover Kids Animal Divisions:**

There will be a Clover Kids Animal Division for exhibitors in beef, sheep, dairy cattle, goat, swine, sheep lead, rabbit, guinea pig (cavy) and poultry. Exhibitors will show for participation ribbons only. There will be no trophies or premium money awarded in the Clover Kids division.

Clover Kids project animals (beef calf, sheep, dairy calf, goat, pig, rabbit, poultry, guinea pig) must be identified and entry forms submitted with the County 4-H Office by the appropriate deadline for each project animal. For deadline dates see appropriate animal area of the Sarpy County Fair Book. The beef and dairy calves must be born after April 1 and before June 15 of the current calendar year. Age and size of sheep and goats should be appropriate to the exhibitor. For safety purposes, the appropriateness of animal age and size to the Clover Kids exhibitor will be at the discretion of the superintendent. Rabbit and poultry entries have no age limit. Beef and dairy calves can be a heifer or steer. Lambs, a ewe or wether and goats, a doe or a wether. Rabbits and poultry can be female or male. Ram lambs can be shown intact the year they are born.
