General Information:

All exhibitors will give a presentation about their companion animal. Presentation should cover the information on the score sheet found below. The presentation may include characteristics, health, history and care of the animal they are showing.

Entries in the Companion Show are judged on the overall health and appearance of the animal, and the exhibitor's presentation and knowledge of the animal. Cats are not judged according to breed standards.

Following the presentation, exhibitors will be interviewed individually on the knowledge and care of their animal.

RULES:

- 1) **Number of Entries Per Exhibitor:** Only two exhibits are allowed. 1 from each different species* per exhibitor. Dogs, guinea pigs, rabbits and poultry will be shown at their respective shows. This will be indicated on the sign up at <https://www.surveymonkey.com/r/M5SNST6> *i.e. 1 cat and 1 reptile not 2 reptiles. Email questions to Rachel at Rwright4@unl.edu
- 2) **Housing of Animals:** Individual owners are responsible to see that animals are properly caged and cared for.
 - a) The animals must be supplied with food and water during exhibit time.
 - b) All cages must provide adequate airflow as needed by the animal.
 - c) If an animal is displayed in a travel cage instead of its normal cage, the exhibitor can prepare a display such as a poster or photographs showing the animal in its normal home.
- 3) **Health Requirement:** Animals shall be free of fleas, ticks, mites, lice, or other parasites or diseases. Any animals showing signs of parasites or disease will not be judged.

- a) Ferrets and cats are required to be current on their vaccinations of rabies, panleukopenia, viral rhinotracheitis, and calicivirus. Participants **must** have a veterinarian fill out the Vaccination form found at: <https://go.unl.edu/e5kt>
 - b) If a cat is not declawed, the claws must be clipped. This will be a point of judging during the competition.
 - c) No expectant or nursing mother animals may be entered in the show.
- 4) **Dress Code:** Exhibitors are required to wear 4-H show attire. Failure to do so will result in a lowered ribbon placing. Dress code is:
- a) white shirt with 4-H emblem or a 4-H shirt
 - b) pants/jeans
 - c) closed toe shoes
 - d) no hats
- 5) **Show Procedure:**
- a) Exhibitors must be present at time of showing.
 - b) Animals must be housed in a cage at all times of the show unless asked to remove them by the judge.
 - c) Each exhibitor will be asked to give a presentation on their animal. The characteristics, health, and care of the animal should be provided in this presentation. Following the presentation, exhibitors will be interviewed on knowledge of their animal and its care.
 - d) Exhibitors must clean up their own exhibit area.
- 6) **Premiums for the Companion Animal Show are pay level 5.**
