

Training can be completed two ways: <u>yqcaprogram.org</u> Face-to-Face Training: \$3.00 Fee, Pre-registration REQUIRED online Online Training: \$12.00 Fee
April 28 - Gage County Progress Show, Gage County Fairgrounds, Beatrice July 6 - Invitational Dairy Show, Gage County Fairgrounds, Beatrice July 13 - Nemaha Valley Livestock Show, Adams July 18 - Wymore Area Livestock Show, Arbor State Park, Wymore July 24- 28 Gage County Fair & Expo August 23- September 2 - Nebraska State Fair, Grand Island	Following training, print certificate from website, bring into Extension Office by June 15. NO LATE CERTIFICATES ACCEPTED; exhibitor will be ineligible to show at the Gage County Fair.

Requirements to show at County Fair

Must complete all 4: 4-H Enrollment, YQCA, ID sheets, & County Fair Entry

EID tags, Green Tags, and ID sheets available at Extension Office. ID sheets required for all livestock, dairy, & rabbits. Premise ID required for all animals with 840 EID tags.

**All livestock entered in registered classes are required to turn in registration papers with ID sheets OR at time of check-in at County Fair. Livestock will be moved to commercial class if registration papers cannot be provided by fair time. Must be registered under immediate family or ranch name.

Requirements to show at State Fair

In addition to Enrollment & YQCA, complete: Nominations, DNA, & State Fair Entry

EID Tags and DNA envelopes available at Extension Office. <u>All 4-H/FFA BREEDING livestock, MARKET</u> <u>livestock and FEEDER CALVES will now be required to submit a DNA sample/envelope to be eligible to</u> <u>exhibit at the Nebraska State Fair</u>. Nomination fee: \$7.00. All fees will be paid online during the nomination process; nominations are not complete until all fees are paid. All nominated and validated animals will be automatically listed as an option for State Fair Entry.
