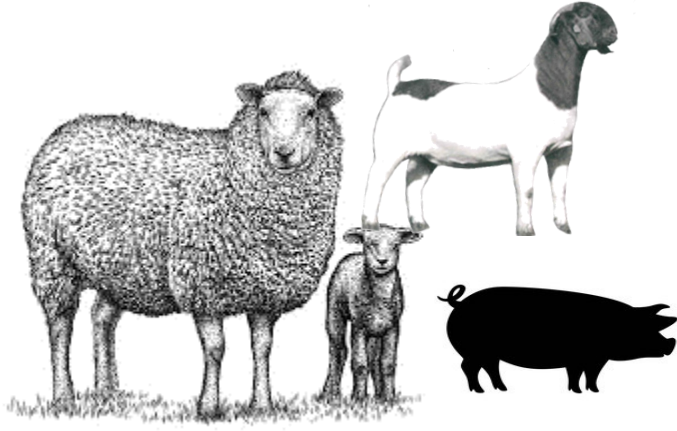

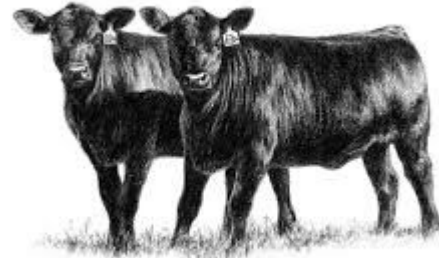

Market Goat: \$250 and \$200

Market Sheep: \$250 and \$200

Breeding Beef: \$150 and \$125

Market Beef: \$250 and \$200

Market Swine: \$250 and \$200





#### **General Show Information:**

- Open to all 4-H and FFA members.
- Exhibitors must be at least 8 and no more than 18 years old before January 1, of the current year.
- The Show Committee will have the final decision on class breaks and registration paper discrepancies.
- Please bring your own bedding and clean up before leaving.
- Dress: Show attire – 4-H/FFA shirt not required. NO halter tops or sleeveless shirts/blouses.

#### **Classes:**

- **Showmanship**: All ages before January 1, of the current year.  
Senior Division - 14 and older; Intermediate Division - 11-13; Junior Division - 8-10.  
Clover Kids - 5-7 (non-competitive and sheep / goats only).

- **Swine Show Information**

**Show order:** Swine followed by Showmanship

- ⇒ All pigs must have a 4-H/FFA tag in place to be eligible to show. Pigs will be shown by weight.  
No re-weighs.

- **Sheep & Meat Goat Show Information**

**Show order:** Sheep and Sheep Showmanship followed by Goat and Goat Showmanship

#### **Meat Goats:**

- ⇒ All meat goats must have a scrapies identification tag. Meat goats will be shown by weight.  
No re-weighs.
- ⇒ Goats are to have milk teeth and there shall be no evidence of breaking of the skin or eruption of the two permanent front teeth.
- ⇒ Goats must have horns blunted.
- ⇒ Goats are to be shown with neck chains or smooth collars only.
- ⇒ Market goats may be doe or whether kids.
- ⇒ Short scrotum, cryptorchid and buck kids are not eligible.
- ⇒ Does and wethers will show together.
- ⇒ No Dairy Goats.

#### **Market Lambs:**

- ⇒ All market lambs must have a scrapies identification tag.
- ⇒ Market lambs will be shown by weight. No re-weighs.

- **Beef Show Information**

**Show Order:** Breeding Heifers, Market Heifers/Market Steers, Showmanship

#### **Breeding Heifers:**

- ⇒ Heifers must be born between 9/1/22 and 12/31/23
- ⇒ Heifers will be shown by age.
- ⇒ All breeding heifers must be identified by legible ear tattoo or tag.

#### **Market Heifers/Market Steers:**

- ⇒ All market animals must be born in 2023.
- ⇒ All Market Steers and Heifers will be shown by weight.
- ⇒ All market beef must have a current Nebraska 4-H or FFA ear tag in place to be eligible to show.
