

Financial report from Karen Zierke for plant fair 2024.

Did well despite no Friday sales due to weather.

Pam Foltz communicated some suggestions for plant fair next year including needing clarification of discounts on plants for master gardeners so better checks and balances can be done.

Other suggestions/concerns voiced by members:

Vendor evaluations were presented.

Suggestions for ways to advertise vendors better as well as recruiting vendors.

-Members were encouraged to make contact with vendors when attending various events with vendors to encourage them to participate in our plant fair/vendor market in 2025.

It was suggested to advertise our event as "Master Gardeners Plant Fair and Vendor Market.

Deb D. suggested idea of featuring certain vendors in the weeks before plant fair on Facebook. Suggestion was also made to feature certain plants on Facebook to generate interest.

Suggestion was made to look into Nebraska Tourism for advertising for our event as well as looking into being included in Bargain Byway booklet

Speakers on Saturday were well attended. It was discussed moving speakers out into area of plants but was determined to much background noise.

Discussion was held regarding starting to sell plants earlier on Friday evening which would require modifying potluck time. Will discuss for next year.

Suzanne brought up about moving annual plant fair forward one week due to competition from other events. Other members voiced concern would interfere with graduations

An appreciation gift was presented to Pam for all of her work she does for our plant fair and Master Gardeners in general.


