Connie presented information regarding plant fair signs ordered from Blackburn Manufacturing in Neligh. Four single side banners advertising plant fair were presented that will be placed @ locations in Norfolk. Tabletop banner-\$54 that Wayne will pick up in Lincoln and bring to plant fair. Banners from Blackburn Manufacturing--\$230 for 4 banners

Brian and Trent will place signs @ areas discussed around Norfolk. An auger was left @ extension office to dig holes. It was reported that 400 cashier tickets have been ordered. Bench cards for plant signage are also ordered.
