## POULTRY SHOW RULES

- A. See General Rules and General Livestock Rules and Regulations.**
- B. NUMBER OF ENTRIES PER EXHIBITOR** - A 4-H member may enter 8 birds in each class with the exception of broilers (3) and production birds (3). Exhibitors are not to exceed a maximum of 8 birds in each division. All poultry exhibited must be grown in a 4-Hers poultry project.
- C. IDENTIFICATION** - 4-H members may identify a maximum of 20 birds by listing the breed, sex and class number on an Identification Affidavit and submitting it to the Extension Office by closing **June 15**. Leg bands are not required.
- D. PRE-ENTRY** - Poultry entries, including showmanship, to be eligible to exhibit at the County Fair, must be pre-entered on a GREEN Entry Sheet (available at the Extension Office or online) OR entered online at <https://nemaha.fairwire.com>. Entries are due by **June 15<sup>th</sup>**. List whether the bird is a cockerel, cock, pullet or hen.
- E. HEALTH REQUIREMENTS** - Health certificate not required. No additional testing required for Nebraska origin poultry. All poultry (including pigeons) for exhibition shall be free of parasites and show no signs of disease during the exhibition. May be testing required by the State Department of Agriculture.
- F. SHOWMANSHIP** - **All 4-Hers must exhibit a bird in showmanship and need to enter showmanship class on the pre-entry form.** Participants may use any bird they choose (chicken, waterfowl, turkey) so long as it was raised and trained by the 4-H member. Judging showmanship is based on grooming and training of the bird and the appearance and behavior of the exhibitor. Exhibitors must vocally explain the steps in their routines and the merit of the bird. Showmanship is the skill of the exhibitor in presenting and explaining the bird before the judge. The excellence of the bird is not considered in scoring. There will be a five minute time limit to complete the showmanship presentation. The judge may ask questions of the exhibitor at the close of the routine. Refer to Livestock Showmanship General Rules for more information.
- G. CARE OF POULTRY AT THE FAIR** - All poultry require food and water at all times.
- H. BREEDS** - To be eligible for breed exhibition, cockerel, pullet, cock or hen chicken entries must be fair representatives of one of the breeds listed in the American Standard of Perfection.
- I. MINIMUM WEIGHTS** - The minimum weights for exhibition birds will be as stated in The American Standard of Perfection and the Bantam Standard. The minimum weights for production birds will be 3 lbs for females and 4 lbs for males of light breeds and 4 lbs for females and 5 lbs for males of heavy breeds.  
**Poultry not meeting weight requirements will not be eligible for the premium sale.**
- J. BROILERS & PRODUCTION/LAYERS**
- BROILER PROJECT RULES**
    - 4-H members will be responsible to: 1) raise the broilers, 2) exhibit a pen of three at the fair, 3) complete and exhibit the broiler record book, and 4) participate in Poultry Showmanship.
    - FEED AND PERFORMANCE RECORDS** must be entered at the time of broiler and production check-in.
    - A pen of broilers shall consist of three male or three female birds 6-9 weeks of age. They will be judged for meat production qualities only and need not necessarily conform to breed standards.
  - PRODUCTION/LAYERS**
    - PERFORMANCE RECORDS** must be entered at the time of production bird check-in.
    - PRODUCTION TRIO** - A pen of egg production birds can be hybrids, crossbred or purebred and shall consist of 3 sexually mature females. Egg production females will be judged for production qualities only and need not necessarily conform to breed standards. Hen must be in egg production.
- K. EGG EXHIBITS** are limited to three dozen per exhibitor. Class options will consist of 1 dozen white, brown or colored eggs. Eggs will be judged according to uniformity of size, weight and color as well as cleanliness. Do not refrigerate prior to exhibiting eggs. 4-Hers may exhibit ONE dozen of each color.
- L. RULES FOR BANTAM & OTHER POULTRY** - The rules for standard size chickens apply equally to bantams and waterfowl where applicable.
- M. PRESENCE DURING JUDGING** - Each 4-H exhibitor **MUST** be present at the exhibit area during judging. If the participant or a substitute showman approved by the superintendent is not present, the exhibit will not be judged.

### PIGEON RULES

- A. See General Rules and General Livestock Rules and Regulations.**
- B. NUMBER OF ENTRIES PER EXHIBITOR** - Each exhibitor may enter 4 birds in each class, but not to exceed a maximum of 8 birds.
- C. IDENTIFICATION** - 4-Hers may identify up to 20 birds by documenting their class, breed and sex on an ID affidavit due by closing on **June 15** at the Extension Office. List whether the bird is a cock or a hen.
- D. HEALTH REQUIREMENTS** - Refer to Poultry Division general rules.
- E. SHOWMANSHIP** - Refer to Poultry Division general rules.
- F.** All pigeons in Class 950 will be RAISED in the current year by the 4-H member showing the bird. The bird cannot be purchased from anyone else.
- G. CARE OF PIGEONS DURING THE FAIR** - All poultry require food and water at all times.
