^{**}Tattoo: State Fair Breeding Beef-Registered Breeding Beef are REQUIRED to have a tattoo and registration papers. Commercial Breeding Beef may use a tattoo or 840 EID tag.

^{***}DNA-ALL STATE FAIR LIVESTOCK entries (Beef, Sheep, Swine, Goats) are required to submit DNA. Market, Breeding, Feeder Calves-ALL ENTRIES are required to submit DNA. DNA entries are \$7/each and paid online by exhibitors. All DNA entries are valid for State Fair and Aksarben.
