## PERKINS COUNTY 4-H ENTRY DEADLINE FOR THE 2024 PERKINS COUNTY FAIR IS NOON; TUESDAY, JUNE 25. NO LATE ENTRIES WILL BE ACCEPTED.

- Livestock entries that did not turn in proper ID forms by June 3 will be VOID.
- Market livestock exhibitors that <u>do not</u> complete quality assurance training by the July 1 deadline will be able to show their livestock but <u>will not be eligible to sell</u>.

- Clothing/Style Show Participants-Parents/Families/Leaders will NOT be allowed in the judging rooms judging day-July 10 (judging in Imperial this year). Everyone is invited to the Public Style Show Saturday, July 20 (immediately following the 12:30 PM 4-H Awards Presentations) at the Perkins County Fairgrounds (Dance Hall).
- Static Entry Tags-Tags will be mailed to families. Please attach tags to exhibits before entry day. Exhibits will be interview judged.
- <u>Livestock Statement of Disclosure</u> (forms included in this mailing)-These will be turned in at livestock weigh in/check in (mandatory for ALL exhibitors even if medications were not given)
- <u>Reminder</u>-Static exhibits will be released to 4-H exhibitors immediately following the 4-H Awards Presentations/Public Style Show.
