Based on Nebraska Department of Environmental and Energy records, your chemigation certificate will expire on December 31, 2023.

So, if you plan to chemigate during 2024, you will need to complete a training session and pass a written test to become recertified.

Requirements for initial and recertification are the same; however, those needing to be *recertified* may opt for the online training version. The online training directions can be accessed at the bottom of the page at: http://water.unl.edu/cropswater/chemigation.

A training manual and calibration workbook will be provided at the training/certification location OR can be picked up (not required) at any Extension office prior to the certification session. A complete list of training locations is listed on the NDEE chemigation page. If you pick up training materials prior to the training session, please bring your Chemigation Training Manual, Calibration Workbook, No. 2 pencil, and calculator along to use for the training and test. If you do not preregister, you will receive a new copy of the training materials the day of the training. Training and testing will take approximately 2.5 hours.

There is no charge for the training or the manuals.
