COUNTY ID REQUIRED: County Livestock Affidavit, EID tags

ID Deadline: June 15th

ALL swine to be shown at State Fair and Aksarben MUST have hair sample for DNA on file. Deadline for DNA and online nomination is -June 15th.

The Gosper and Phelps County 4-H Swine Shows are "non-terminal shows."

If market animals do not meet weight requirements, animals will be shown in classes in which no purple ribbon or championship honors will be awarded.

PHELPS COUNTY SWINE

Premiums: Purple 4.00, Blue 3.75, Red 3.00, White 2.25

Weight Limits: 220 lbs min to 320 lbs max

<u>Phelps County:</u> To provide uniform appearance, and at the request of the Hog packer, Phelps County is discouraging total body clipping. Hog will be inspected at weigh-in and must have at least 1/2 inch length hair on the body and 1/4 inch length hair on the head and ears. Hog not meeting these requirements will result in dropping one ribbon placing in all market and showmanship classes. No clipping of Hogs will be allowed on the fairgrounds. At the fair, hogs will be housed 2 per pen, with a maximum of 2 pens per exhibitor. Pen dividers are allowed.

County ID Required: County Livestock ID and farm ear tag

All Breeding Gilts are to be born after December 1 of the previous year. Gilts must be identified using an EID tag and an official ID Form by June 15 of current year. Breeding gilts may not be identified as both breeding gilts and market swine. Purebred gilts must have registration papers and meat industry standards for breed type, color and conformation. Commercial gilts can be crossbred gilts or gilts of pure breeds that do not meet breed standards. Gilts may not be shown in both market and breeding classes. Purebred and Commercial gilts will be shown together

To provide uniform appearance, Gosper County is discouraging total body clipping. Hog will be inspected at weigh-in and must have at least 1/2 inch length hair on the body and 1/4 inch length hair on the head and ears. Hog not meeting these requirements will result in dropping one ribbon placing in all market and showmanship classes. No clipping of Hog will be allowed on the fairgrounds.
