Reminder Important Dates:

- Horse ID Sheets, Horsemanship Advancement Level requirements, entry process for State Horse Show **Due 5:00 p.m. on June 1**

Reminders:

- Now is a good time to complete the written tests for Horse Levels. Written Test horse levels must be done **before July 15th** for Pierce County 4-Hers. Please call the office to setup a time, so a test can be ready for you.
- All 4-H/FFA <u>BREEDING</u> livestock, MARKET livestock and <u>FEEDER CALVES</u> are required to submit a DNA sample/envelope to be eligible to exhibit at the Nebraska State Fair. Stop by the office to get your **NEW DNA envelopes**.
- Families the planning on taking livestock to Nebraska State Fair need to put their animal information into the Showstock Manager database https://showstockmgr.com and pay the nomination fee by June 15.

Pierce County Premium Fair Books:

Pierce County Fair Premium Books will be ready on Middle of May for families that have already enrolled on 4-H Online. One Premium book will be given per family. Paper Fair entry and Livestock Entry Form will be due on July 3rd at the Pierce County Extension Office. Please do not create a new profile if you have previously enrolled in 4-H, even a different county or state.

ALL Youth and Volunteers/Club leaders must be enrolled by **June 15th, 2024**.

Please make sure to include youth T-shirts size in case we have T-shirts donated.

This year there are changes to the project selection when enrolling. The project selection is now optional with the EXCEPTION of HORSE and SHOOTING SPORTS PROJECTS due to the parental consent required for participation.

Livestock Quality Assurance 2024



There's much more to 4-H livestock projects than simply showing animals at the fair. That's why all Nebraska 4-H members enrolled in livestock projects must complete annual quality assurance training. Through the Youth for the Quality Care of Animals program, members learn about food safety and animal well-being. Youth enrolled in beef, dairy cattle, goat, poultry, rabbit, sheep, and swine projects may complete online training courses or attend in-person training workshops held by their county Extension office. Face-to-Face Training

Face-to-Face trainings are scheduled for May 29th (1 p.m. and 6 p.m.) at the Wayne County Fairgrounds and June 11th (1:00 p.m. and 6:00 p.m.) at the Pierce County Fairgrounds. To register for this Face to Face training you will need go to the YQCA website is yqcaprogram.org. Log on and select "Pierce County YQCA" and the time that you want (either 1 pm or 6 pm). After you have selected your time will have to pay a \$3 fee per youth. This fee has to be paid online and not in the office. Pierce County 4-Hers - if you attend the in person training at the Wayne County YQCA or the Pierce County YQCA, we will be reimbursing you the \$3 at the event for coming to the in person training.



Livestock Identification & Nomination Deadline

Any 4-H member planning to exhibit livestock at the Nebraska State Fair must complete the appropriate livestock identification and nomination requirements by **June 15**. This process makes an individual animal eligible for entry at the State Fair. Learn more at https://4h.unl.edu/livestock-id.

Livestock & Small Animal Events

Boone County Arama Shows:

Boone County is hosting Swine, Beef, Sheep, and Goat Arama Shows in Albion, NE. Youth must be 8 (by January 1) and not have passed their 21st birthday by January 1, 2024, except for Swine exhibitors who can be 5 years old by January 1. Swine will show on Friday, May 24, Beef will show on Saturday, May 25, and Sheep and Goats will show on Sunday, May 26. Platte County Showmanship Clinic:

Platte County is hosting a Showmanship Clinic on Saturday, June 22, from 9:30 AM - 3:30 PM at the Ag Park in Columbus, NE. This clinic is open to all 4-H members ages 8-18 and is \$5 per youth. The Great Plains Livestock Judging Circuit is a lineup of contests held throughout the state giving youth the opportunity to perfect their skills in preparation for the Nebraska 4-H Premier Animal Science Event (PASE). Qualifying youth must attend a minimum of two contests in addition to the PASE livestock judging contest in order to be eligible for awards and scholarships. Animal News

ID Information:

All animals (except dogs, cats, small animals, and poultry) shown at the county fair must be identified on a 4-H identification form (affidavit). Make sure forms are filled out completely. Completed forms can be emailed, mailed, or dropped off at the Pierce County Extension Office.

Goats:

All goats being exhibited needs a individually identified with some form of USDA official Scrapie ID. A legible tattoo in the ear or tail may be used in place of a scrapie tag for Dairy Goats. The tattoo will match registration papers if the goat is registered.

Sheep:

All sheep (breeding & market) must be tagged with a USDA Scrapie ID.

Swine:

All swine exhibited in the 4-H/FFA swine show must be tagged with a 4-H/FFA or EID ear tag. County tags are \$1.00 each and EID tags are \$3.00 each. ID sheets are due to the Nebraska Extension Office on June 15. Tagging needs to be done prior to the ID deadline.

Rabbit:

4-H Rabbits - ID sheet must include breed of rabbit, sex, tattoo, birth date, and color of the rabbit. Rabbits exhibited at the State Fair must be tattooed and entered into ShoWorks by August 10th.

Beef:

<u>Cow/Calf Pairs</u> - include on the ID sheet ear tag number of calf as well as cow, age of cow, sex of calf, and birth date of calf.

<u>Registered Breeding Beef</u> - All registered breeding beef must have legible tattoo in the ears. The tattoo will match registration papers if the breeding beef. Include on the ID Sheet the breed, tattoo, birth date.

<u>Commercial Breeding Beef</u> - All commercial beef must have a tattoo or EID tag or County Only ear tag. On the ID Sheet it must have breed, tattoo or tag number, birth date.

<u>Market Beef</u> - All market beef must have a EID tag or County Only ear tag. On the ID Sheet it must have breed, sex, tag number.

Feeder Calves and Bucket Calves - need to be tagged with a 4-H ear tag. Tags can be purchased from the Extension Office. County tags are \$1.00 each and EID tags are \$3.00 each. EID tags and DNA samples are needed to exhibit a Feeder Calf at State Fair. Tagging needs to be done prior to the ID deadline.

Cats, Dog, & Household Pet Exhibitors:

Remember - proof of current vaccinations for cat, dog, and ferrets are due with fair entries on July 3 and must be current at that time.

Horses:

Markings may be drawn in or photos may be used on the ID sheets. If using photos, clear views of the face and both sides of the horse are needed. Horse level testing for County Fair must be completed by July 15th.

- The State Horse Show in Grand Island is scheduled for July 13-17th. Deadline for entries, ID's, and level testing documentation is June 1, at 4 P.M.
- County Fair: Horse exhibitors have until July 15th to pass Horse Level tests. ID sheets are due June 15th
- Advancement Level Study Guides and Resources are available at https://4h.unl.edu/horse-advancement. Now is a good time to take written test for Horse Levels.

State Fair Requirements:

Animals must be nominated and fees paid online at https://showstockmgr.com/. Cost is \$7.00 per animal. Instructions for entering animals into Showstock Manger website are available at https://go.unl.edu/sfnomination.

• In addition to online nomination:

<u>Market Animals</u> - need DNA sample on file and an EID tag (beef and swine) or USDA Scrapies tag (meat goats/sheep).

Feeder Calves - DNA sample and EID tag.

<u>Breeding Animals</u> - <u>Beef:</u> DNA sample and Tattoo or EID tag accepted for Commercial Heifers, <u>Meat Goats:</u> Scrapies tag, and DNA sample, <u>Sheep:</u> Scrapies tag and DNA sample, <u>Swine:</u> EID tag and DNA sample.

- EID tags (\$3.00 each) and DNA envelopes are available at the Pierce County Extension Office. Exhibitors with animals that have an EID tag must provide a premises ID by **June 15th**.
- State Fair animals must be marked on your county ID sheet.

2024 Online Horticulture Judging Contest

Do you know what it takes to pick the best fruit and vegetables out at the grocery store? Or do you know what judges are looking for when they judge your plants at the county fair? Have you ever wondered, what plant is that!?! We are excited to offer the opportunity to learn these and other important horticulture skills through the Online Horticulture Contest. The contest will be available June 7-21, 2024 at: https://go.unl.edu/online4hhortcontest.

Horticulture judging contest consists of three parts.


- 1. Identification of plant material. Participants identify the plants by common name from a plant list. Specimens may be alive or preserved plant parts like stems, twigs, leaves, flowers, seeds, fruits, roots, bulbs, tubers, or plant.
- 2. The knowledge portion, usually in the form of a true/false or multiple choice quiz. Questions will test the contestant's knowledge of cultural practices for horticultural crops, plant science, pesticides, horticultural careers and other topics related to the production, processing and consumption of horticultural crops.
- 3. The last portion is judging or placings. This is where four different plants, plates of vegetables, or containers flowers are ranked from best to worst based on a set of criteria. Classes are judged on the basis of condition, quality, uniformity, true-to-type, and size.
