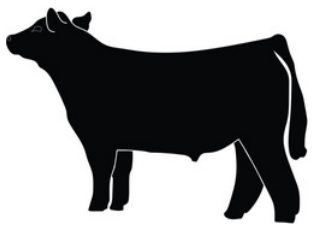

**SHOW RULES:**

- Show is for 4-H and FFA members (ages 8-18 by Jan. 1st)
- "Blow & Go" Rules apply.
- Showmanship divisions are 8-10, 11-13,14-18.
- No more than 4 animals per person {2 market 2 breeding}
- Show attire: No halter tops or sleeveless shirts; 4-H and FFA shirts are not required.
- All market cattle must have current 4-H or FFA ear tags.
- Market Beef Divided by Weight & Sex. Must be born in 2023.
- Breeding Beef Divided by Breed or Commercial born September 2022 through December 2023.
- The Show Committee will have final decisions on class breaks and registration paper discrepancies.
- Nebraska Extension, Keith County Ag Society & Keith County 4-H Council will NOT be held liable for accidents.
- All out-of-state animals must have health and brand papers.
- Barn housing will be on a first come, first served basis. Please bring your own bedding. You may use wood chips. Please clean up any that you bring.
- Generators and extension cords recommended.
