

POLICY 001 – ATVs/UTVs/RECREATION VEHICLES/GOLF CARTS POLICY

The use of auxiliary vehicles, including but not limited to service carts, three-wheelers, four-wheelers, go-karts, “Gators”, side-by-sides, “ATVs”, “UTVs”, motorized sports vehicles, and other four-wheeled recreation vehicles is strictly prohibited for 4-H’ers, 4-H families, and the general fairgoing public within the confines of the Polk County Fairgrounds. The aforementioned vehicles may be used only by members of the Polk County Agricultural Society and Polk County Extension for purposes directly related to the operation of the Polk County Fair.

The pre-approved use of gas and electric golf carts is permitted for 4-H’ers, 4-H families, and the general fairgoing public. All persons wishing to have to use of gas and electric golf carts must provide documentation of the following:

- 1) Sign and abide by FORM 001 - PCAS Golf Cart Rules and Regulations Agreement
- 2) Provide a copy of a valid driver’s license for each person who the golf cart owner permits to drive the vehicle
- 3) Provide proof of liability insurance covering the golf cart

As the owner of this golf cart, I agree that my golf cart and anyone who drives it shall adhere to the following regulations. Any golf cart, regardless of driver, found to be operating outside of these regulations is subject to removal from the Polk County Fairgrounds by the Polk County Agricultural Society President:

- 1) Golf carts shall be operated only by the fully-licensed (age 16 or above) drivers indicated on this form by full name and driver's license number. Copies of each driver's license shall be provided.
- 2) Golf carts shall not exceed speeds of 10 mph while within the confines of the Polk County Fairgrounds.
- 3) Golf carts shall be properly secured when not in use. Keys shall not be left in the vehicle, and the vehicle shall be parked appropriately and in such a way that does not impede other foot or vehicle traffic.
- 4) Golf cart owners shall be required to provide proof of liability coverage for this golf cart.
- 5) The owner of this golf cart takes full responsibility for protecting this golf cart against theft and non-approved usage.
- 6) The owner of this golf cart takes full responsibility for this golf cart, its drivers (including those drivers not mentioned above), the actions of its drivers (including those drivers not mentioned above), any personal or property damages caused by this golf cart or its drivers (including those drivers not mentioned above).
- 7) No golf carts are allowed on the fairgrounds without providing the required documentation.
- 8) Golf carts will not be allowed inside the grandstand or beer garden areas at any time.
- 9) Drivers and passengers of golf carts shall be subject to all open container laws.

Polk County Agricultural Society [PCAS] and/or Polk County Fair [PCF] shall not be responsible for any damage to exhibits, animals, vehicles, merchandise, concession or any other personal property caused by any cause whatsoever. Additionally, fair visitors and participants waive and covenant not to sue and further agree to indemnify and hold harmless PCAS, and/or PCF from any and all claims, costs, causes of action (including reasonable attorneys' fees), relating to loss, injury or damages of any kind, while attending or participating in the Polk County Fair, to the fullest extent permitted by Nebraska law, including claims for negligence committed by the foregoing. Fair visitors and participants assume all risks and dangers associated with attendance or participation in the Fair.
