Favorite Foods Contest:

- 1) When you arrive, check in and select a judging time. You will be asked to let us know if you are competing in another contest. Please be in the building at least 15 minutes prior to your assigned judging time.
- 2) **We have 20 tables thanks to the Saunders County 4-H Council and the Saunders County Ag Society!!** These tables are 34” square folding tables. Tables are available on a first-come, first-served basis or you may bring a small card table for your display. **Do note:** if you bring your own table, it does need to remain at the fairgrounds throughout the entire fair. **There are currently 41 entries so please bring your own table if you have one.**
- 3) The 4-H member will be expected to set up everything for their own display table. **NO PARENTS ALLOWED** in the setup and display area. Please practice at home setting your table display so your 4-Her knows what they need to do. Also, please refrain from speaking with the judge on your behalf. If you need to relay something to the judge, please talk to an extension staff member or superintendent.
- 4) **REMEMBER FOOD SAFETY!!!** Remember that cold foods need to be kept cold and hot foods need to be kept hot. Your food item should be served at the temperature you would serve it at home.
- 5) I understand that waiting can get a little long, so feel free to bring snacks and beverages. However, if you bring food in, please be courteous and clean up after yourselves.
