When purchasing an animal from the livestock auction that you intend to have processed, you will need to make arrangements with the processor of your choice. Many of the area processors have made changes to their services offered, so please make arrangements now to ensure space for your animal. The Scotts Bluff County Sale and Livestock Committees will not be responsible for the transportation of any animal to processors, however if you need help to arrange transportation, please contact Shain Shimic 307-575-3333. On the back of this letter we have enclosed a list of several area processors and more information to help serve you better. Please note that they reserve the right to change their services.
