The Scotts Bluff County Fair Livestock Show and Sale would like our event to be drug free from the animals' perspective. We do this to guarantee to our Livestock Sale Buyers that we are offering a safe and wholesome products. Approved drugs and feed additives are permitted as long as the following conditions are met:

1. The animal in question has had the appropriate withdrawal time for any residues to be absent from the animal as stated on the FDA approved Label.
2. The animal is under care from a licensed veterinarian who deems treatment necessary to prevent further sickness or death. If this is the case, the exhibitor may be asked to hold and care for the animal until the appropriate withdrawal times are met.

Under no circumstances should any human, non-species, or extra label use drugs be used in a food producing animal unless prescribed by a Veterinary-Client Patient Relationship. Other products which may cause a positive test and possible sanctions are:

1. Injectable and Feed Grade Antibiotics
2. Anti-Inflammatories
3. Stimulants or Depressants
4. Anabolic steroids
5. Any product outside the scope of normal livestock production than enhances or adulterates the animal.

The following is in the Scotts Bluff County Fair Book:

All livestock may be tested for illegal residues. The exhibitor will stand the loss if any illegal residue is found in the carcass. Each market livestock exhibitor will submit a signed affidavit certifying correct withdrawal from legal drugs, vaccines or other substances. They will also certify that their entries have not received any non-approved drugs. This affidavit will be presented to the livestock superintendent at animal check-in before the animal crosses the scale.

The Scotts Bluff County Livestock Committee welcomes you to competition at our Show and Sale. If you have any questions or concerns, please contact the chairpersons, species superintendents, extension staff, or FFA advisors for specific advice. On the reverse of this paper, we have a form to track and record any substances given to your animals. This information can be vital in the case of a residue violation. This form will be required to be submitted at the time of weigh in at the beginning of the Scotts Bluff County Fair for your animals to be entered. Thanks for keeping our Livestock Show and Sale a wholesome event for all concerned.

I agree that the animals listed on this form meet all the requirements stated above and will at the Committee's request, be available to be tested for ineligible and illegal substances. If found to have violated this policy, I agree that I will be subject to penalties determined by the committee at that time.
