The year end 4-H Treasurer's Report is due to the Extension Office by February 1, 2024. Don't hesitate to call with guestions!


# **Special Garden Project:**

# **State Fair Updates:**

- Age of Eligibility
  - The age of eligibility in 2024 is now 8 years of age before January 1 (of the current year) for all in-person events (livestock, contests, fashion shows)
- Showmanship Age Divisions
  - o Junior Showmanship (ages 8 to 10 before January 1 of the current year)
  - o Intermediate Showmanship (ages 11 to 13 before January 1 of the current year)
  - o Senior Showmanship (ages 14 to 18 before January 1 of the current year)

#### Awards

 Exhibitors will receive awards for the Division Champions, Reserve Division Champions, Grand Champion Overall, Reserve Grand Champion Overall, and 3rd Overall. Only entries receiving a purple ribbon are eligible to receive champion and reserve awards.

#### Entry Limits

- A 4-H member may exhibit up to 5 beef.
- A 4-H member may exhibit up to 4 sheep.
- A 4-H member may exhibit up to 4 goats.
- A 4-H member may exhibit up to 6 hogs.
- A 4-H member may exhibit up to 6 rabbits.
- A 4-H member may exhibit up to 6 live birds.

#### • Individual Species

- o Sheep: New Breed Class-All Hair Breeds
- Goat: Market goats will show in separate classes; Market Wethers and Market Does (until final selection)
- o Swine: New Breed Classes-Tamworth and Landrace
- Rabbit: New Breed Classes-Blue Holicer and Czech Frosty
- o <u>Dog Skillathon Contest:</u> Added a Junior Skillathon Division and rotated breed ID picture topics

# Diamond Clover

The Nebraska 4-H Diamond Clover Program is a form of recognition for all ages. Members should be setting their goals now and work toward completing them during the 4-H year. The Program has gone through a few changes. The service-learning project that was previously required for the Diamond Level is now a separate program opportunity called Nebraska 4-H Gives Back. # Reminders

#### **New Volunteer Orientation:**

Nebraska 4-H is implementing a new 4-H Volunteer Orientation, which is part of the volunteer screening process. Direct volunteers are required to complete the 4-H Volunteer Orientation during enrollment as a new volunteer and/or during the re-screening process every five years. The volunteer orientation link is located in the direct volunteer screening information in 4-HOnline or at <a href="https://4h.unl.edu/volunteer-orientation">https://4h.unl.edu/volunteer-orientation</a>. Upon completion, the volunteer will receive a confirmation email as well as the county office the volunteer selected during the orientation. The online orientation will take approximately 45 minutes to complete and does not have to be completed in one session.

#### 4-H Volunteer Impact Study – You May Be Contacted:

What you do makes a difference! We are excited to share that our state will be participating in the 4-H Volunteer Impact Study of volunteers in the North Central Region. This survey is being conducted as a part of 12 state effort to document the impact of volunteering.

It will focus on three areas:

- the personal benefits of your volunteer experience;
- the impact you have on the organization by volunteering; and
- how your volunteer efforts contribute to your community in which you live and work.

A random sample of volunteers of 1000 volunteers from each state will be surveyed. This study will be conducted through an electronic survey. If you are selected you will receive an email to let you know you have been selected to participate. You may be picked!!! If you are, please respond. We want to hear from you and learn from your volunteer experiences. Your comments will be used to quantify the personal, organizational and public impacts of volunteers involved with 4-H Youth Development Programs in our twelve-state region. Your impact is great and we want to hear from you!!! There will be a random sample of 1000 volunteers from our state that will be selected to participate. The survey will be distributed on **January 15** and close on **February 15**.

#### 4-H Rabbit Show:

The 4-H Spring Rabbit Show will be held on **Saturday, March 16, 9 a.m.** at Sandhills Global Event Center, 84th & Havelock – South Hall. Open to all youth ages 8–18, with a Clover Kids class for youth ages 5–7. This is a great opportunity for youth to talk to other 4-H'ers about where to purchase a good rabbit for a 4-H project, and to learn and practice showmanship. ## **Horse Stampede:**

The Nebraska 4-H Horse Stampede offers a variety of 4-H horse contests that do not require live animals, including public speaking, demonstration, quiz bowl, art, and photography contests. Youth have the opportunity to display their equine knowledge through these contests both as an individual and as part of a team. The 4-H Horse Stampede is held annually at the UNL Animal Science Complex in Lincoln, Nebraska. # County Animal News



# 4-H Animal Ownership Review:

All beef (including cow/calf pairs and feeder calves), cat, dog, goat, poultry, rabbit, sheep, and swine project animals must be owned by the 4-H member or in partnership with other members of his or her immediate family. Immediate family is defined as members of a household, including parents, brothers, sisters, and youth in the care of the head of the household.

Dairy and dairy goat projects not owned by the exhibitor or immediate family can get permission from the animal's owner if that owner signs the affidavit sheet stating the 4-H member must manage feeding, grooming, fitting, etc. and have access to the animal at least 75% of the time during project season.

Horse projects not owned by the exhibitor or immediate family must have the owner sign the affidavit certifying that the exhibitor will manage and have access to the horse at least 75% of the time during the course of the project following: feeding. grooming, exercising, training, stall management and use of the horse.

Please contact the Extension Office if you have questions concerning ownership requirements.

#### **Livestock Premises Identification:**

All 4-H and FFA market animals with an EID tag are required to have a premises ID. A Premises ID can be obtained through the Nebraska Department of Agriculture and should correlate to the location in which livestock are kept/housed permanently.

- Only one Premises ID is necessary for a family with multiple exhibitors (provided livestock are housed at the same location).
- Only one Premises ID is necessary for an exhibitor that shows multiple species (provided livestock are housed at the same location).
- Any exhibitor that has completed YQCA and exhibited an animal with an EID tag at the Wayne County Fair will have a Premises ID.
- Premises ID numbers must be turned into the Extension Office by June 15.
- Special notation and update: 4-H/FFA exhibitors will need to mark "Production Unit" only under Premises Type. Information can be found at <a href="https://nda.nebraska.gov/adt/premises.html">https://nda.nebraska.gov/adt/premises.html</a> and the Extension Office.

#### **Horse Leaders:**

All leaders who give the skills portion of the level 1 and 2 advancement level tests are required to take a certification course in order to give these tests. The online course consists of watching videos and taking a short quiz. Once completed the leader will receive a certificate and will be put on the advancement level list as certified to give the level 1 and 2 skills tests. Only certified leaders can pass youth on the skills test (riding).

#### **Cow/Calf Exhibitors:**

Reminder: Intermediate and senior age division cow/calf exhibitors must show a calf from their cow/calf pair at halter, either as a feeder calf or baby breeding heifer. Make sure the calf is ID'd as either a baby breeding heifer or feeder calf. Feeder calves need a 4-H tag.

## Youth for the Quality Care of Animals (YQCA)

All 4-Hers that plan to exhibit beef, goat, sheep, swine, rabbit and poultry projects are required to complete the Youth for the Quality Care of Animals (YQCA) course. The YQCA course will fulfill the livestock quality assurance requirements for eligibility to exhibit animals at any 4-H show and will also fulfill the Youth PQA requirement set by National Pork Producers.

Youth can complete YQCA by attending a Face-to-Face training or completing an online course. Cost for the Face-to-Face training is \$3.00/youth and the online charge is \$12.00/youth. Payment for either option is made online.

Test-out Option: Test-out options are available to youth in the first year of Intermediate (age 12) or Senior (age 15) age levels. There is no test-out option for Juniors. If passed, youth will not be required to complete the annual training requirements for the remainder of their current age level (Intermediate 12-14; Seniors 15-18) Each test consists of 50 randomly selected questions. Youth must score 80% or better for certification. Participants will have only one chance to take the test-out option. If youth fail, they will not be provided another opportunity to test out of that age level and will be prompted to take the instructor-led or web based training annually. If passed, payment for the completed test-out course will be required after completion of the test. No payment is required to attempt the test. Test-out costs are:

Intermediate: \$36 (\$12 x 3 years of certification)

Senior: \$48 (\$12 x 4 years of certification)

Face-to-Face Training Scheduled:

May 29, 1:00 & 6:00 p.m., Wayne County Fairgrounds and June 11, 1:00 & 6:00 p.m., Pierce County Pavillion, Pierce - Youth will need to register online for the training.
