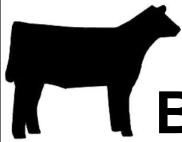

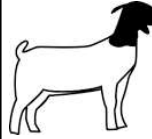

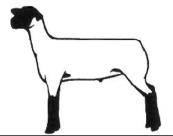

RULES AND REGULATIONS - On Back

Sponsors: Boone County 4-H Jr Leaders, Boone County Big Give, and Area Businesses

2024 RULES AND REGULATIONS

General Show Information:

This show is open to all Nebraska 4-H and FFA members. Exhibitors must be 8 years old before January 1st and have not passed their 21st birthday before January 1st of the current year, except swine exhibitors. Swine exhibitors must be 5 years old before January 1st and have not passed their 21st birthday before January 1st of the current year. Livestock may be brought in after 11:00 a.m. on Friday, May 24th. The Show Committee will have the final decision on class breaks and registration paper discrepancies.

Dress: Show attire – 4-H/FFA shirt not required. NO halter tops or sleeveless shirts/blouses.

Weigh Cards: For Market Hogs, Market Cattle, Market Goats & Market Lambs, exhibitors will declare weights on all market animals. Weigh cards must be completed and turned in during the designated check-in time and location. The weight listed on the weigh card will become that animal's official declared weight to be used for assignment to a class and for weigh-back purposes.

Weigh Backs: A weigh back will be incorporated for all 1st and 2nd place purples in each class. A 5% variance from the declared weight at check-in will be allowed. Animals not meeting the 5% variance over the declared weight at check-in will not be eligible for any champion awards. The 3rd place purple may also be requested to weigh back if the 1st or 2nd place purples do not meet the 5% variance requirement.

Swine Show Information

Purebred Hogs: Must show purebred registration papers at time of check-in.

Breeding Gilts: All breeding gilts must be born on or after January 1 of the current year. Breeding classes will be shown by breed - Purebred and Crossbred (light and dark).

Market Swine: Open to barrows & gilts. Market classes will be shown by breed - Purebred and Crossbred (light and dark).

Mkt & Brdg: All swine must have a current Nebraska 4-H or FFA ear tag in place, or identified by the Universal ear notch system in both ears to be eligible to show.

Showmanship: Senior Division - 16 and older before January 1, 2024
Intermediate Division - 12-15 before January 1, 2024
Junior Division - 8-11 before January 1, 2024
Novice Division - 5-7 before January 1, 2024

Sanctioned Show:

This is a Nebraska Swine Circuit (NSC) sanctioned show. All NSC rules will be enforced and posted on show day.

Show Order: Breeding Gilts, Market Swine, Showmanship

Breeding Heifers: Heifers must be born between 9/1/22 and 12/31/23. Heifers will be shown by breed. All registration papers must be presented at check-in. Heifers without registration papers will show in the commercial class. All breeding heifers must be identified by legible ear tattoo(s) or EID tag.

Showmanship: Senior Division - 16 and older before January 1, 2024
Intermediate Division - 12-15 before January 1, 2024
Junior Division - 8-11 before January 1, 2024

Market Heifers: Market heifers must be born in 2023. All heifers will be shown in one division and classes will be divided by weight.

Market Steers: Steers must be born in 2023. Steers will be shown by breed. Classes will be divided by weight. All registration papers must be presented at check-in. Steers without papers will show in the Crossbred class.

All market beef **must have a current Nebraska 4-H or FFA ear tag in place** to be eligible to show.

Sanctioned Show:

This is a Junior Nebraska Cattlemen (JNC) sanctioned show. All JNC rules will be enforced and posted on show day.

Show Order: Breeding Heifers, Showmanship, Market Heifers, Market Steers

Market Goat & Sheep Show Information

Showmanship: Senior Division - 16 and older before January 1, 2024
Intermediate Division - 12-15 before January 1, 2024
Junior Division - 8-11 before January 1, 2024

Breeding Goats: Yearling does must be born 9/1/2022 to 8/31/2023. Doe kids must be born on or after 9/1/2023. Classes will be divided by age.

Market Goats: All market goats **must have a scrapie tag**. Market goat classes will be divided by weight. Goats are to have milk teeth and there shall be no evidence of breaking of the skin or eruption of the two permanent front teeth.

Goats must have horns blunted.

Goats are to be shown with neck chains or smooth collars.

Market goats may be doe or wether kids. Short scrotum, cyptorchid and buck kids are not eligible. Does and wethers will show together. No Dairy Goats.

Showmanship: Senior Division - 16 and older before January 1, 2024
Intermediate Division - 12-15 before January 1, 2024
Junior Division - 8-11 before January 1, 2024

Breeding Ewes: Ewe lambs must be born on or after 9/1/2023. Yearling ewes must be born 9/1/2022 to 8/31/2023. Classes will be divided by breed. All registration papers must be presented at check-in. Ewes without registration papers will show in the crossbred class.

Market Lambs: All market lambs **must have a scrapie tag**. Market lamb classes will be divided by weight.
